Planar Schottky barrier rectifier with an integrated guard ring for stress protection, encapsulated in SOD123F small Surface-Mounted Device (SMD) plastic package.

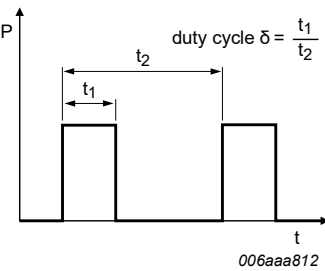
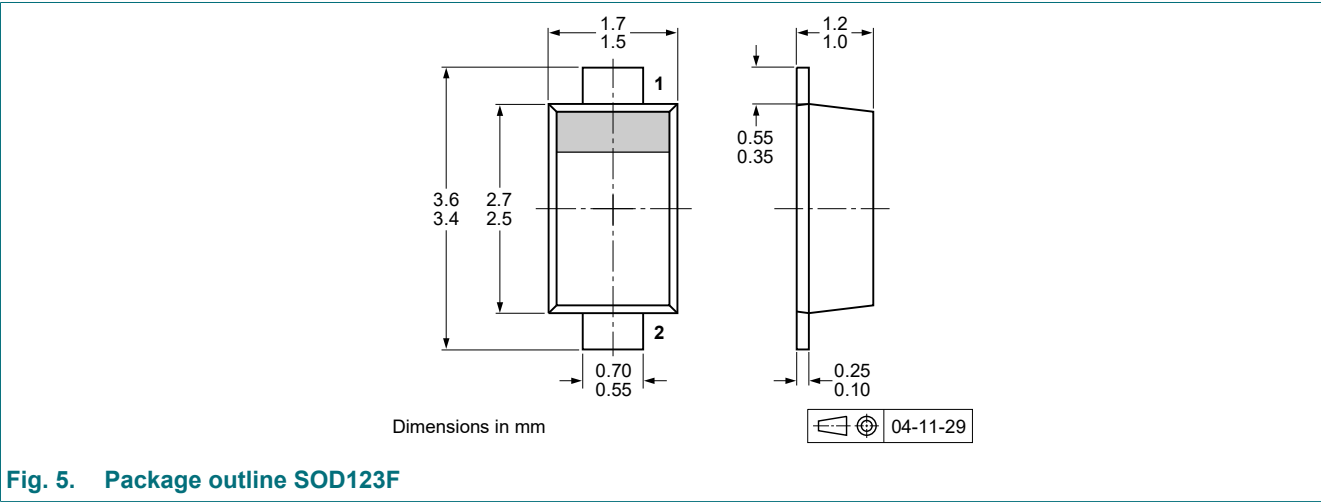


Fig. 4. Duty cycle definition

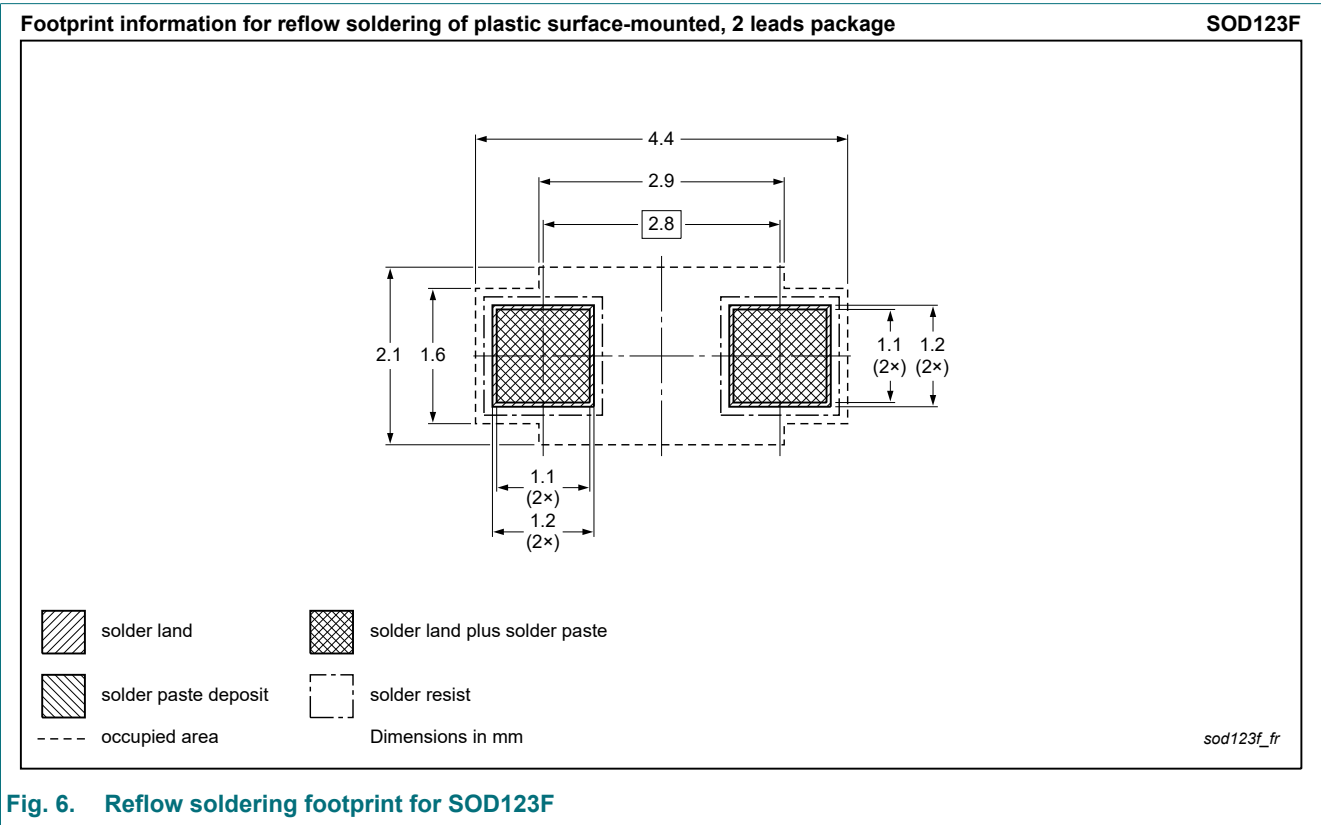
