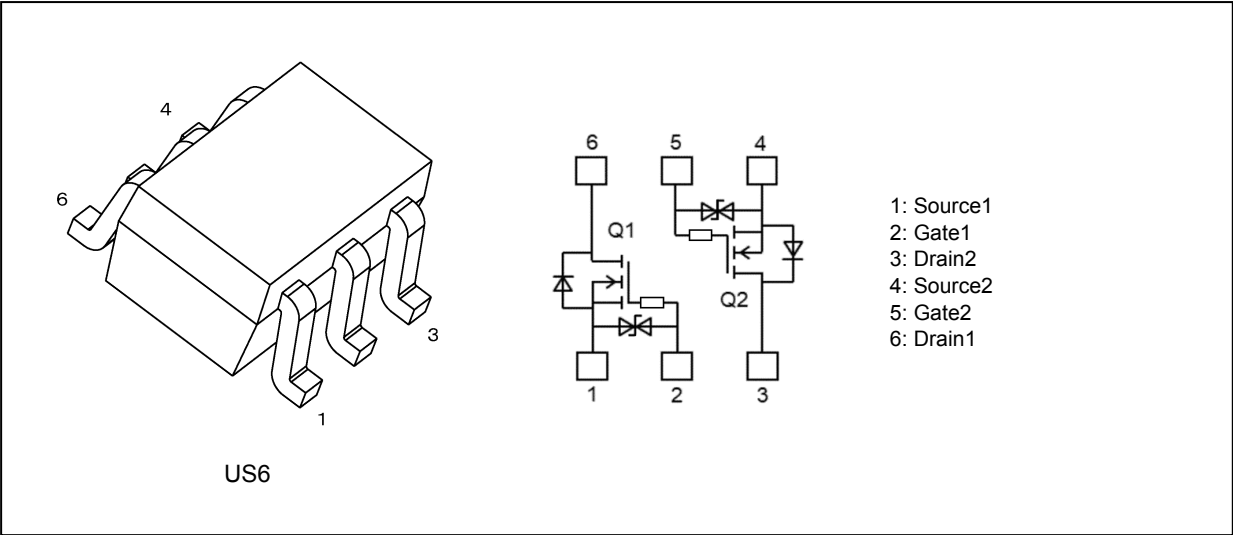

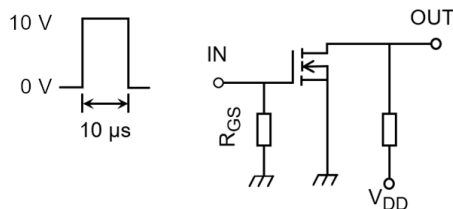


Fig. 6.3.1 Switching Time Test Circuit

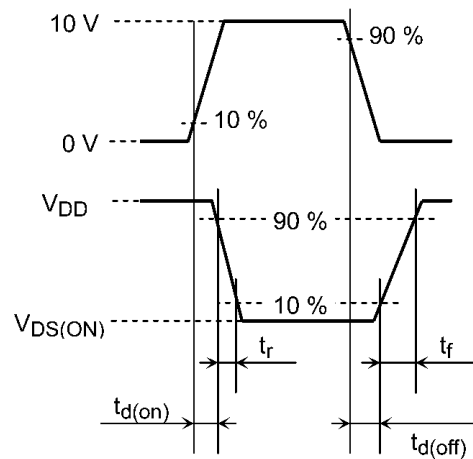


Fig. 6.3.2 Input Waveform/Output Waveform

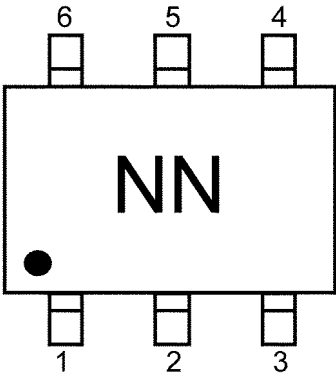

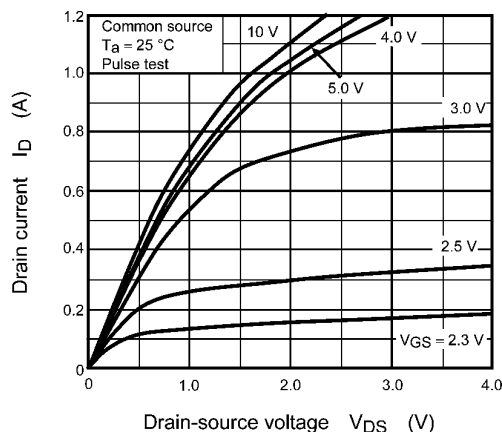


Fig. 8.1 $I_D - V_{DS}$

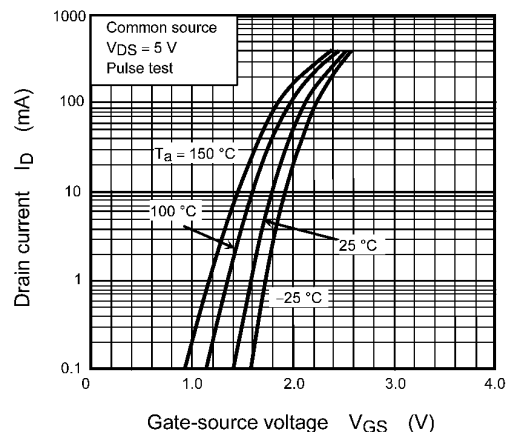


Fig. 8.2 $I_D - V_{GS}$

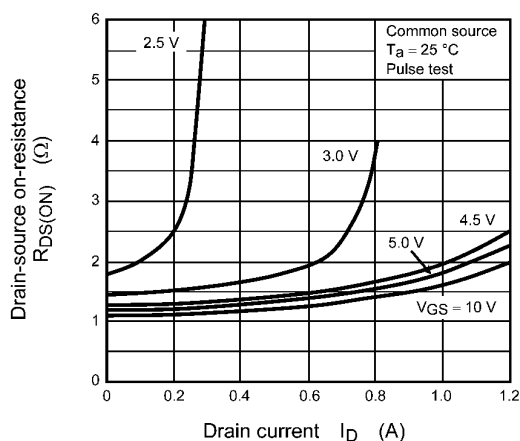


Fig. 8.3 $R_{DS(ON)} - I_D$

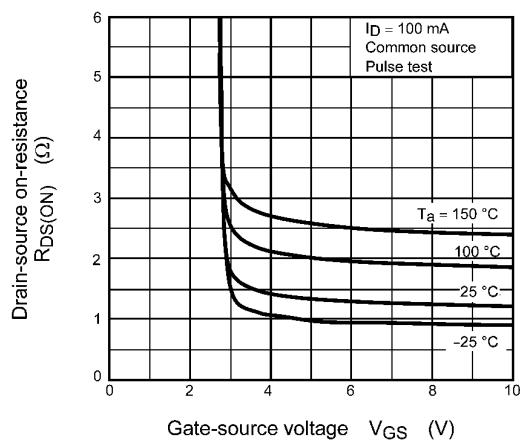


Fig. 8.4 $R_{DS(ON)} - V_{GS}$

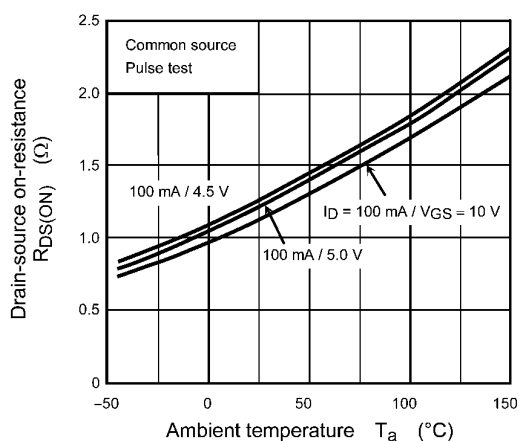


Fig. 8.5 $R_{DS(ON)} - T_a$

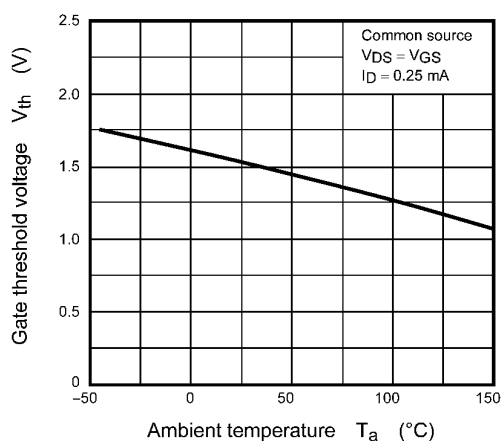


Fig. 8.6 $V_{th} - T_a$

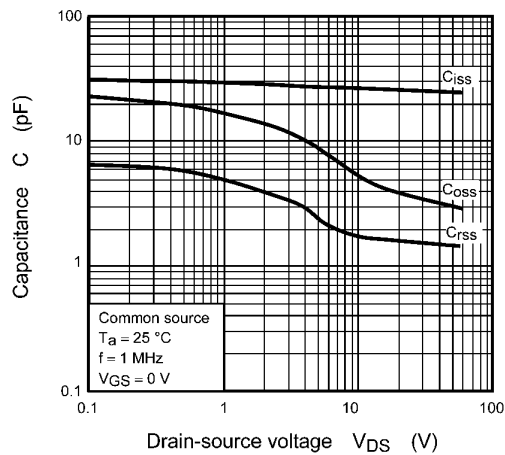


Fig. 8.7 C - V_{DS}

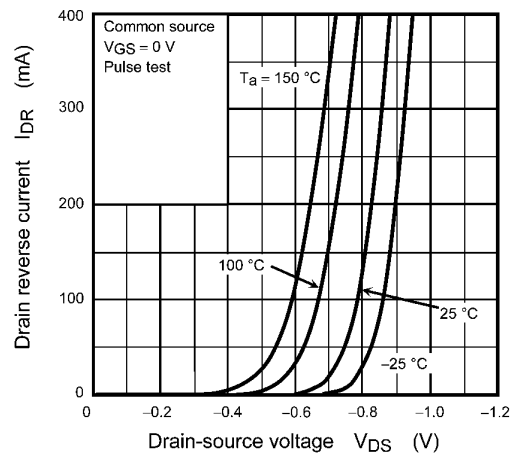


Fig. 8.8 I_{DR} - V_{DS}

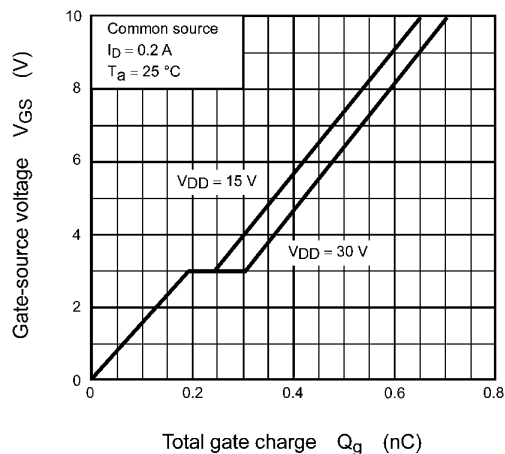


Fig. 8.9 Dynamic Input Characteristics

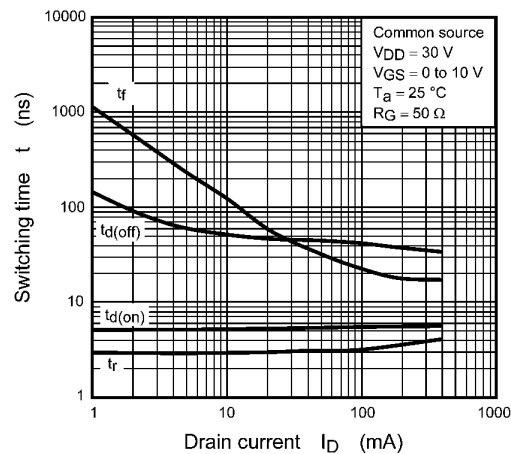
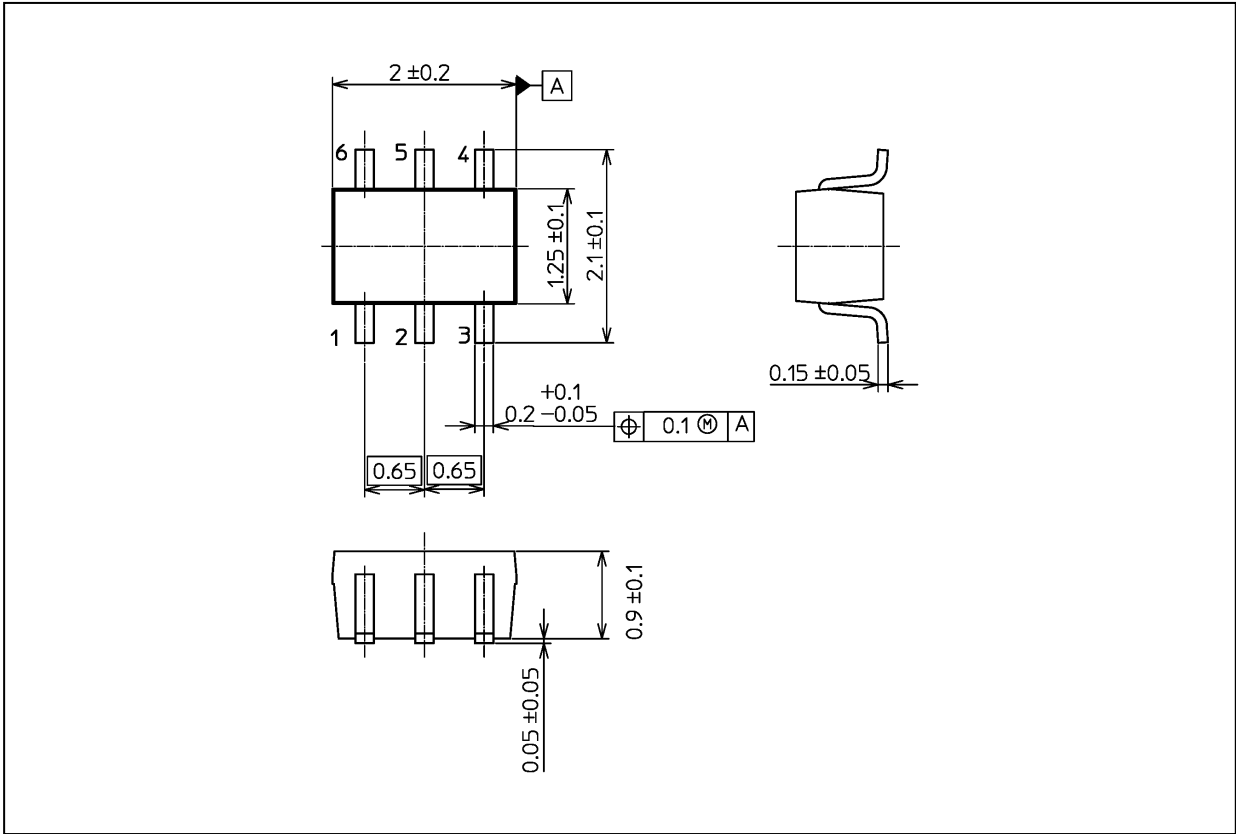


Fig. 8.10 t - I_D
