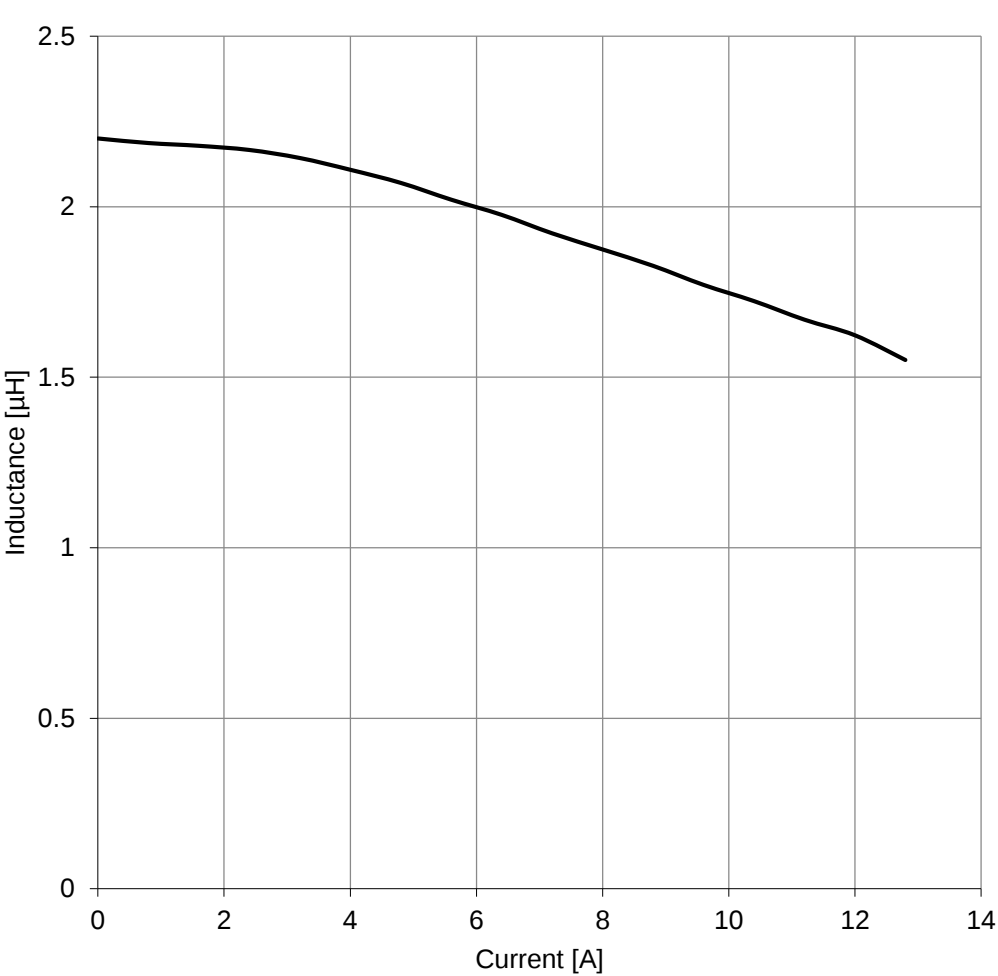

Typical Temperature Rise vs. Current Characteristics:



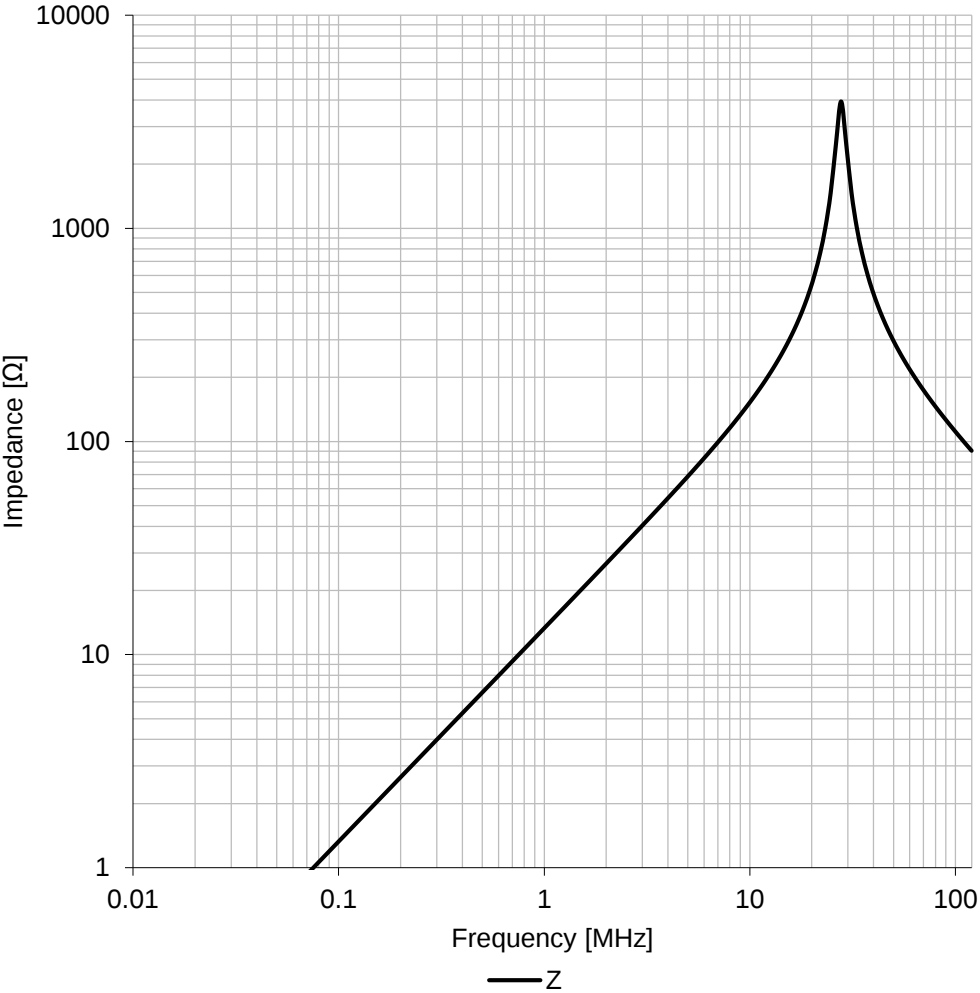
Typical Inductance vs. Current Characteristics:

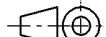

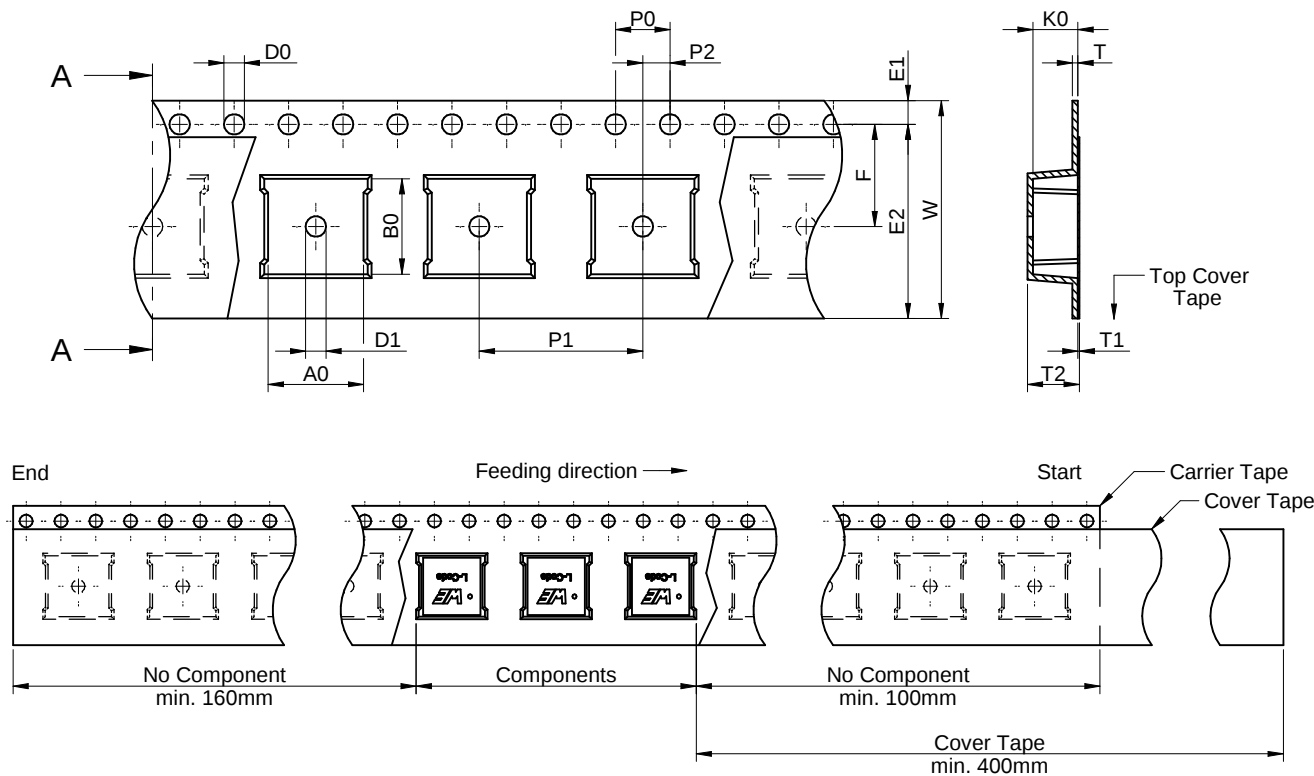
Typical Impedance vs. Frequency Characteristics:

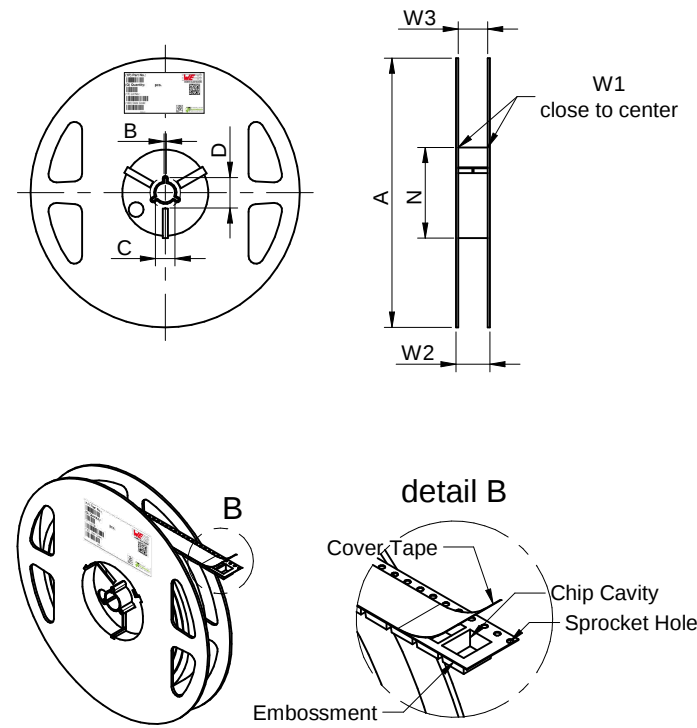

### Soldering:
