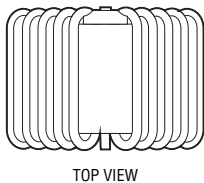

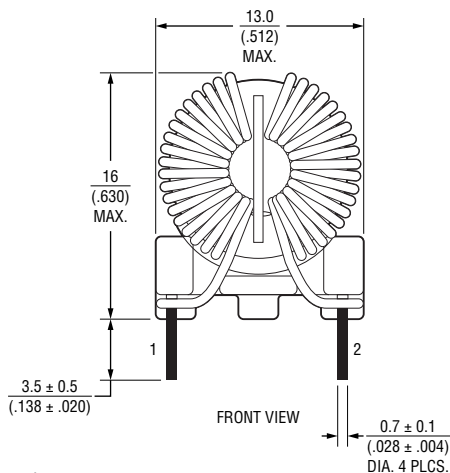


TOP VIEW

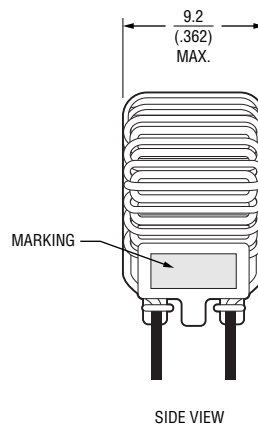


BOTTOM VIEW

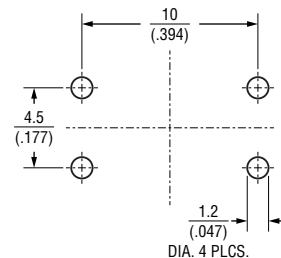


FRONT VIEW

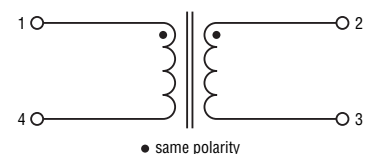

Schematic



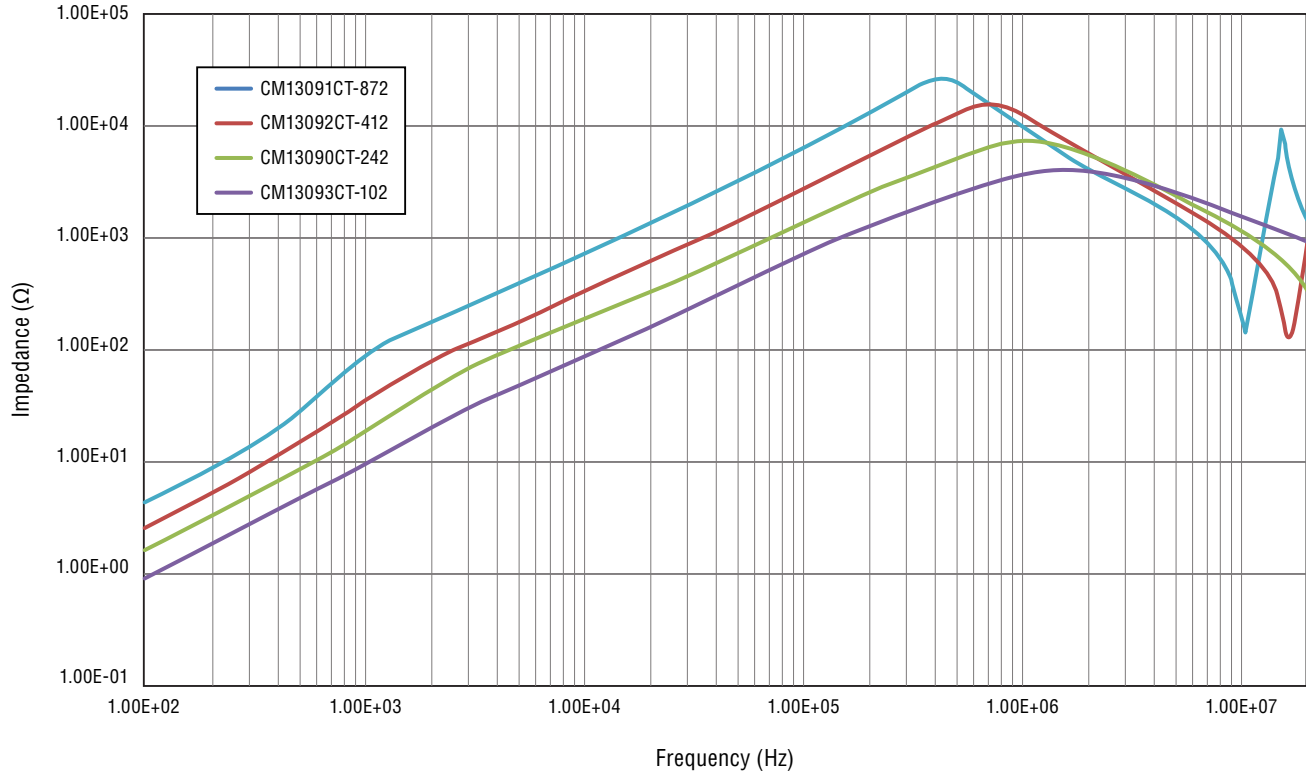
