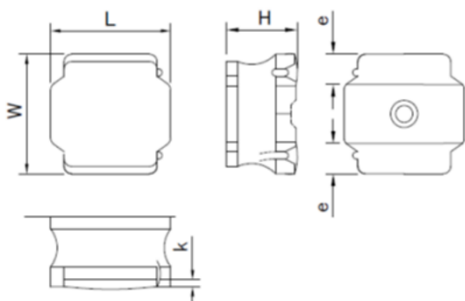

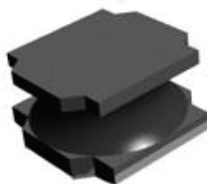

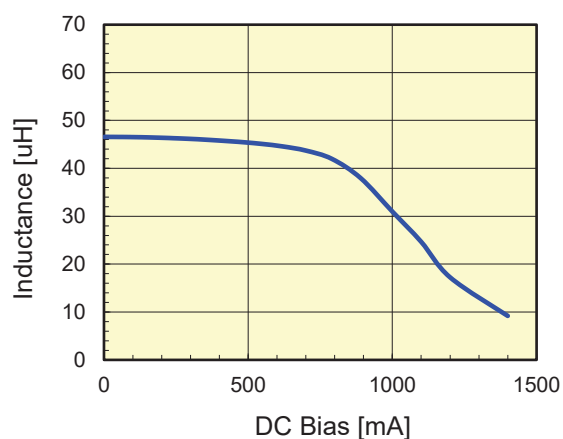

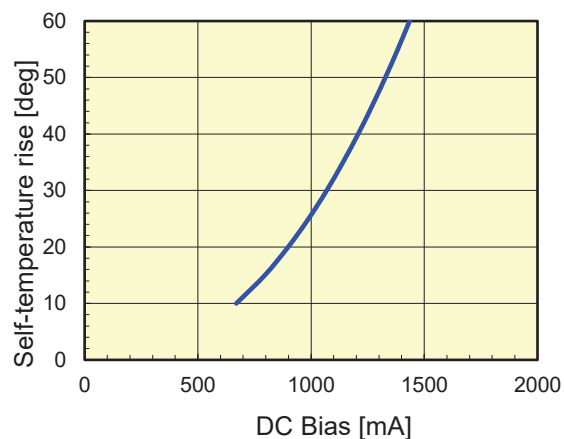

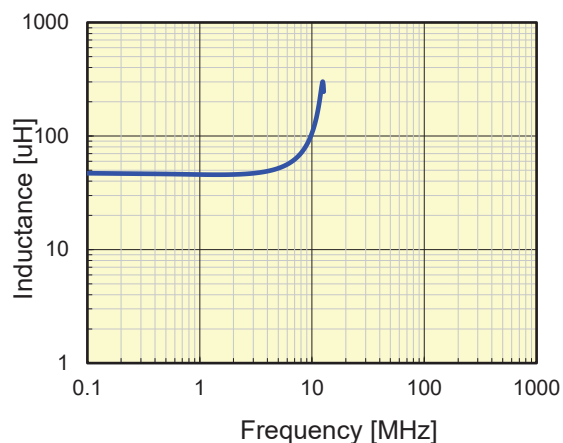
DC Bias vs Inductance
