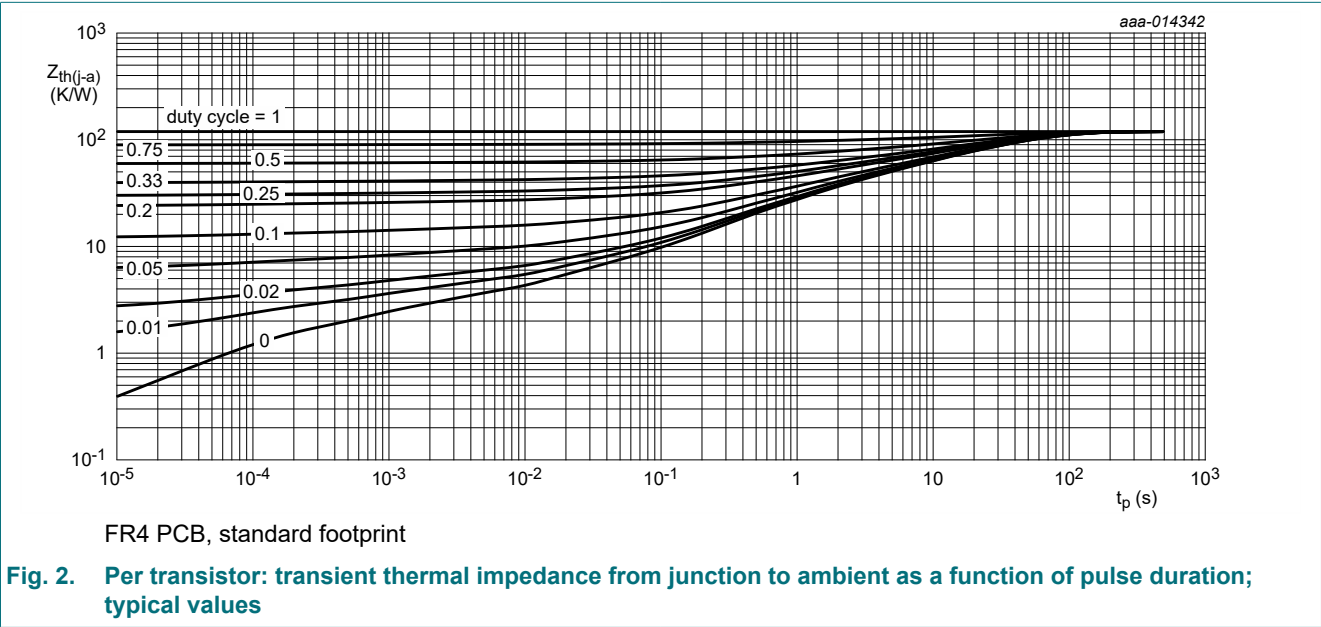


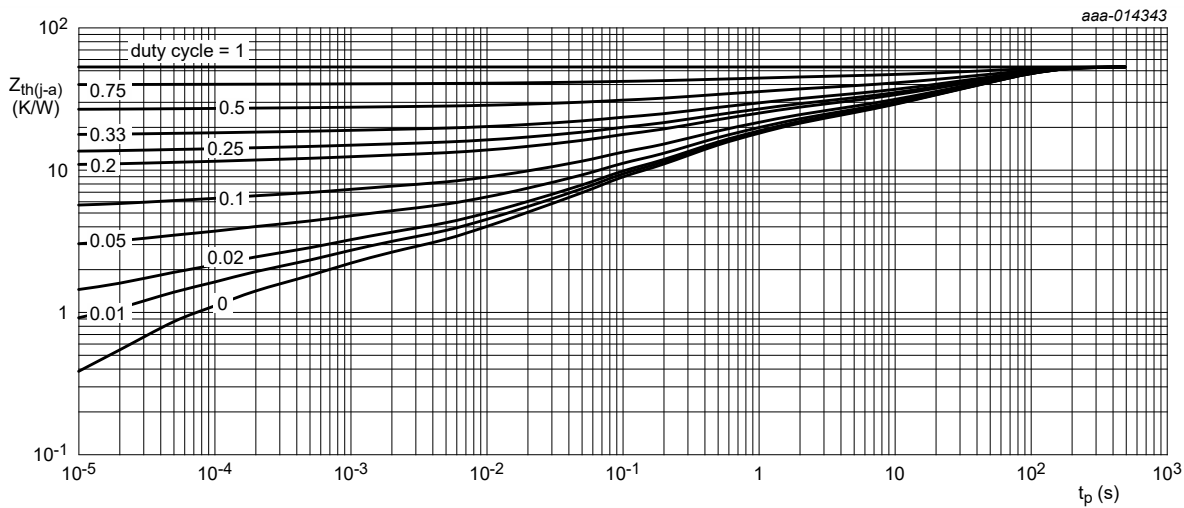

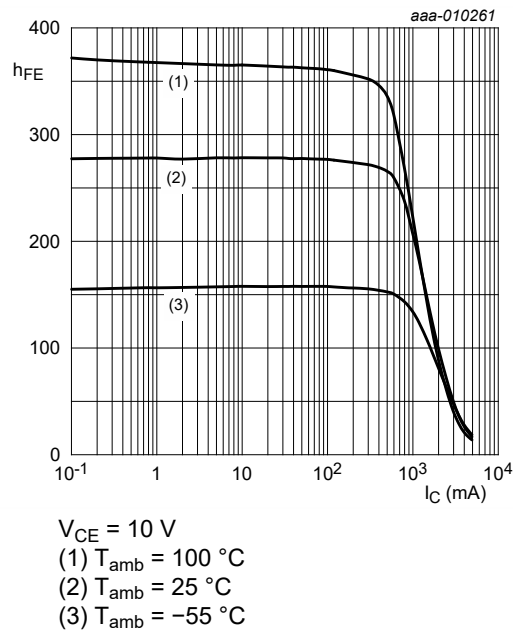


Fig. 4. DC current gain as a function of collector current; typical values

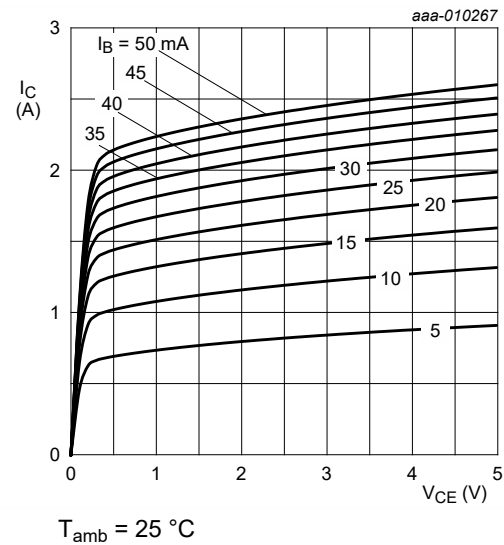


Fig. 5. Collector current as a function of collector-emitter voltage; typical values

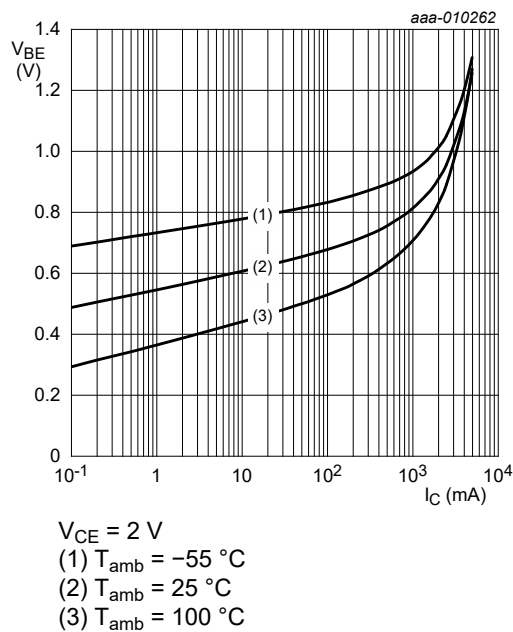


Fig. 6. Base-emitter voltage as a function of collector current; typical values

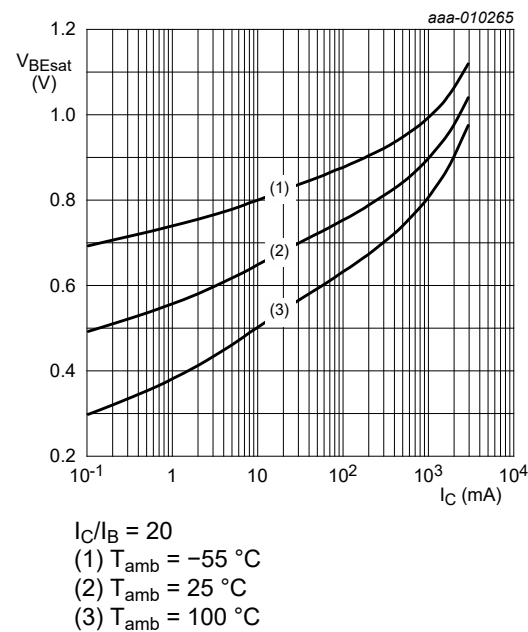


Fig. 7. Base-emitter saturation voltage as a function of collector current; typical values

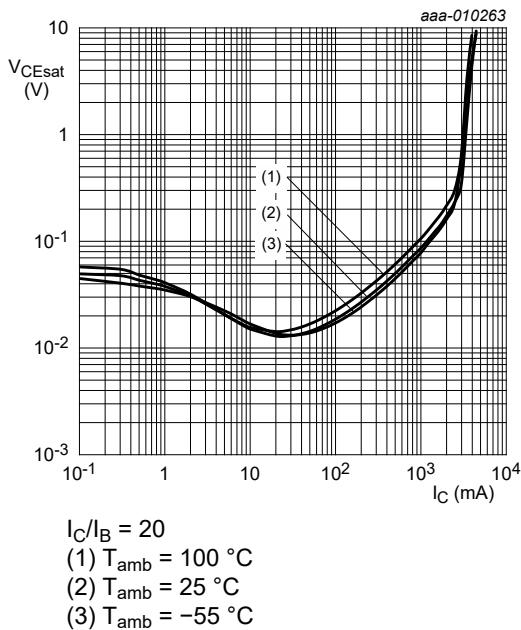


Fig. 8. Collector-emitter saturation voltage as a function of collector current; typical values

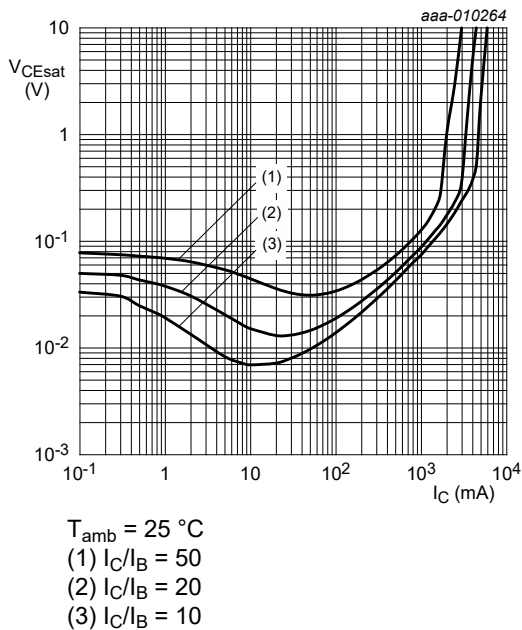


Fig. 9. Collector-emitter saturation voltage as a function of collector current; typical values

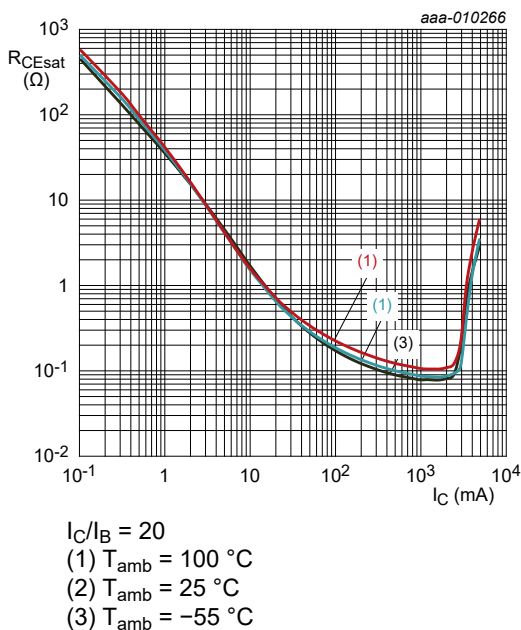


Fig. 10. Collector-emitter saturation resistance as a function of collector current; typical values

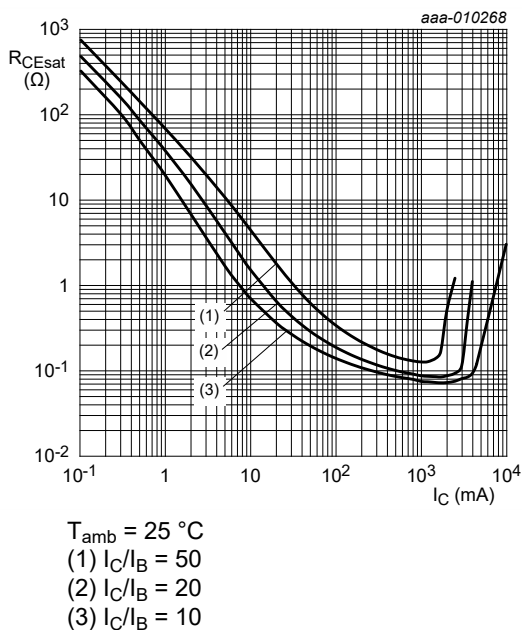


Fig. 11. TR1 (NPN): Collector-emitter saturation resistance as a function of collector current; typical values

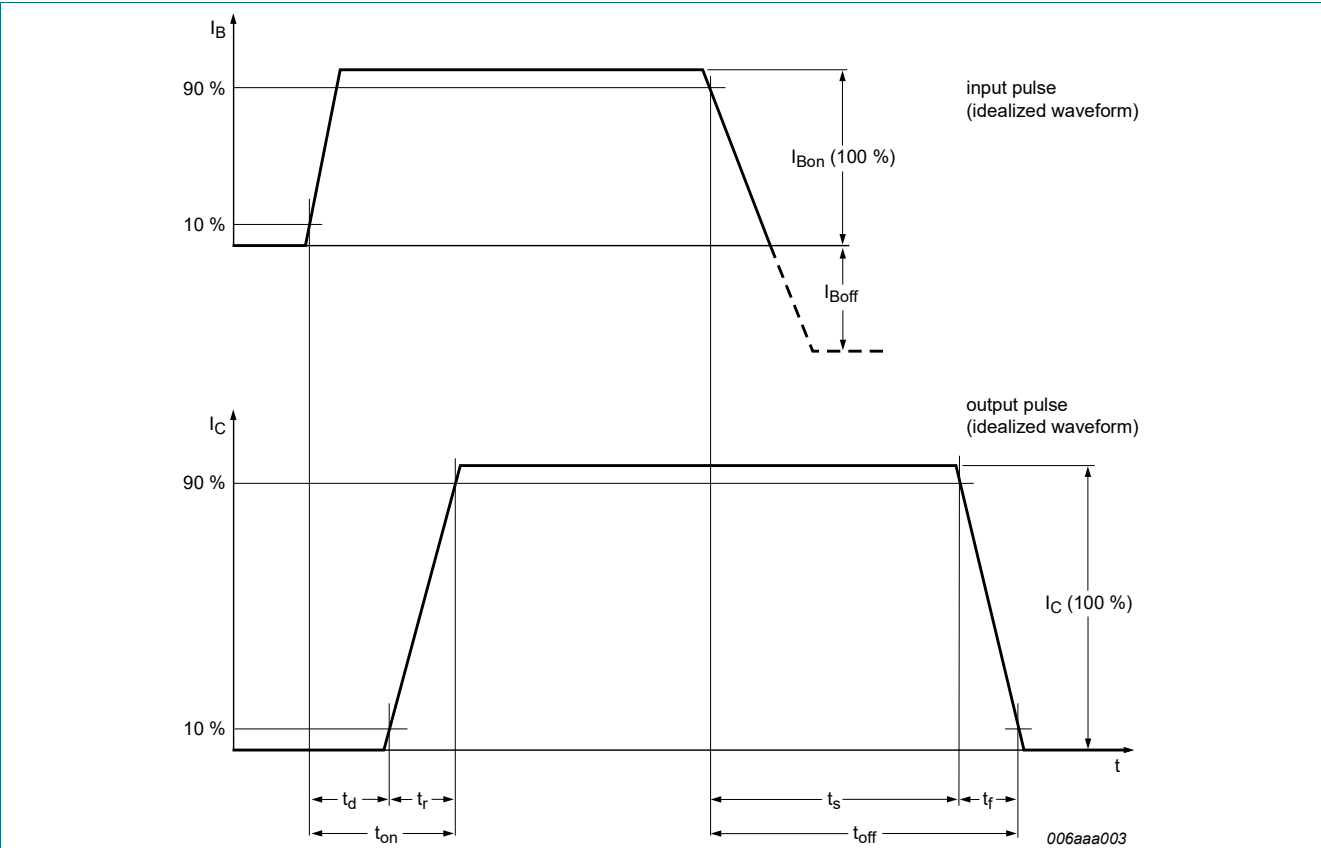


Fig. 12. Switching time definition

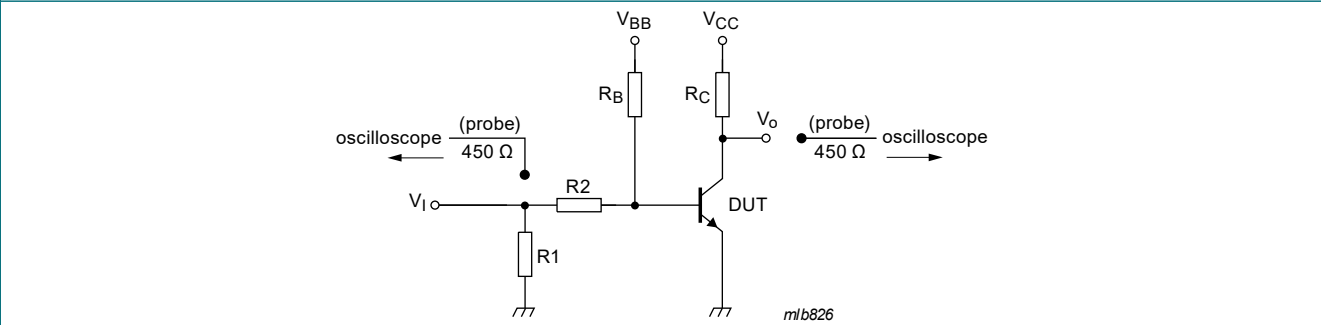


Fig. 13. Test circuit for switching times

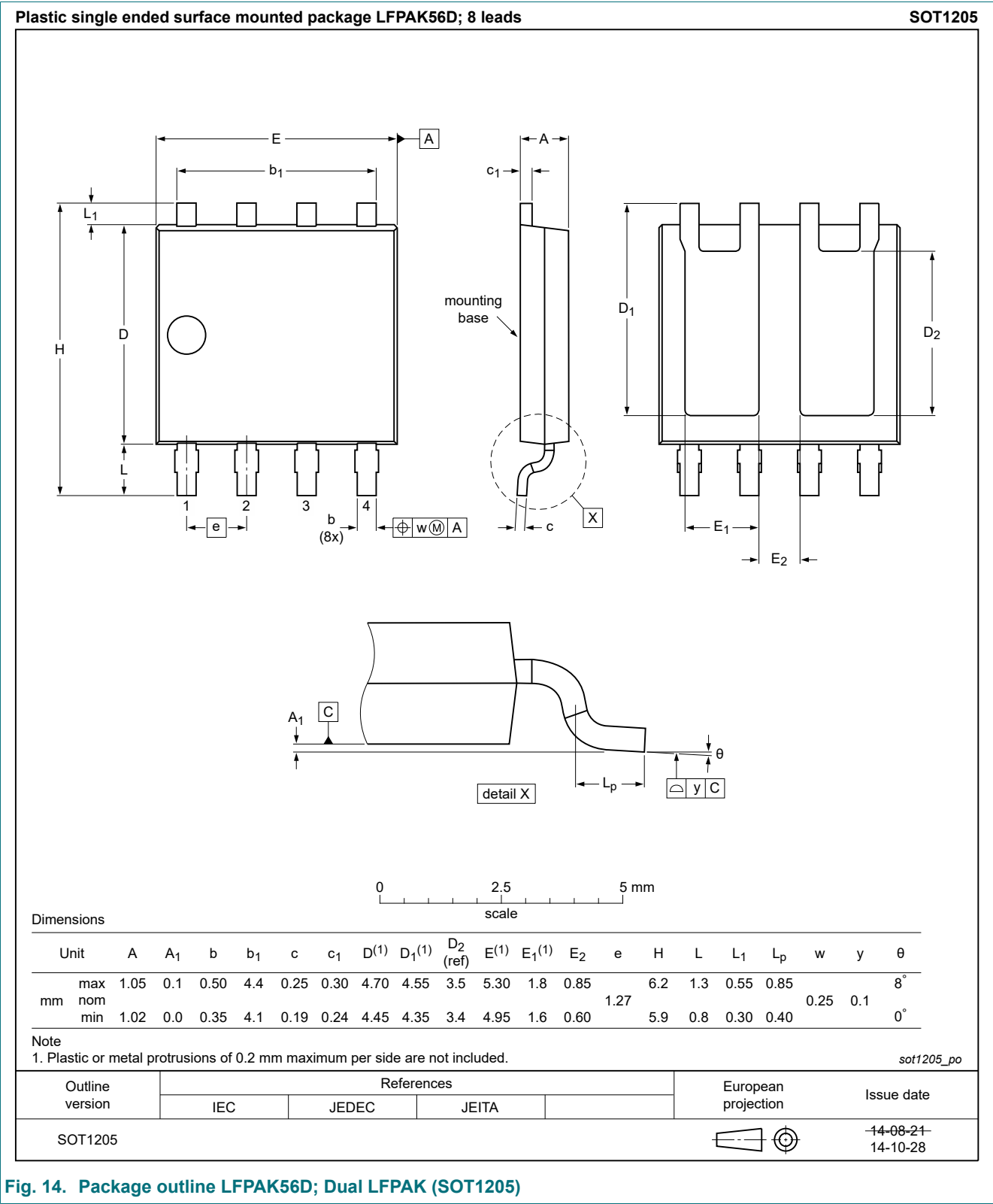
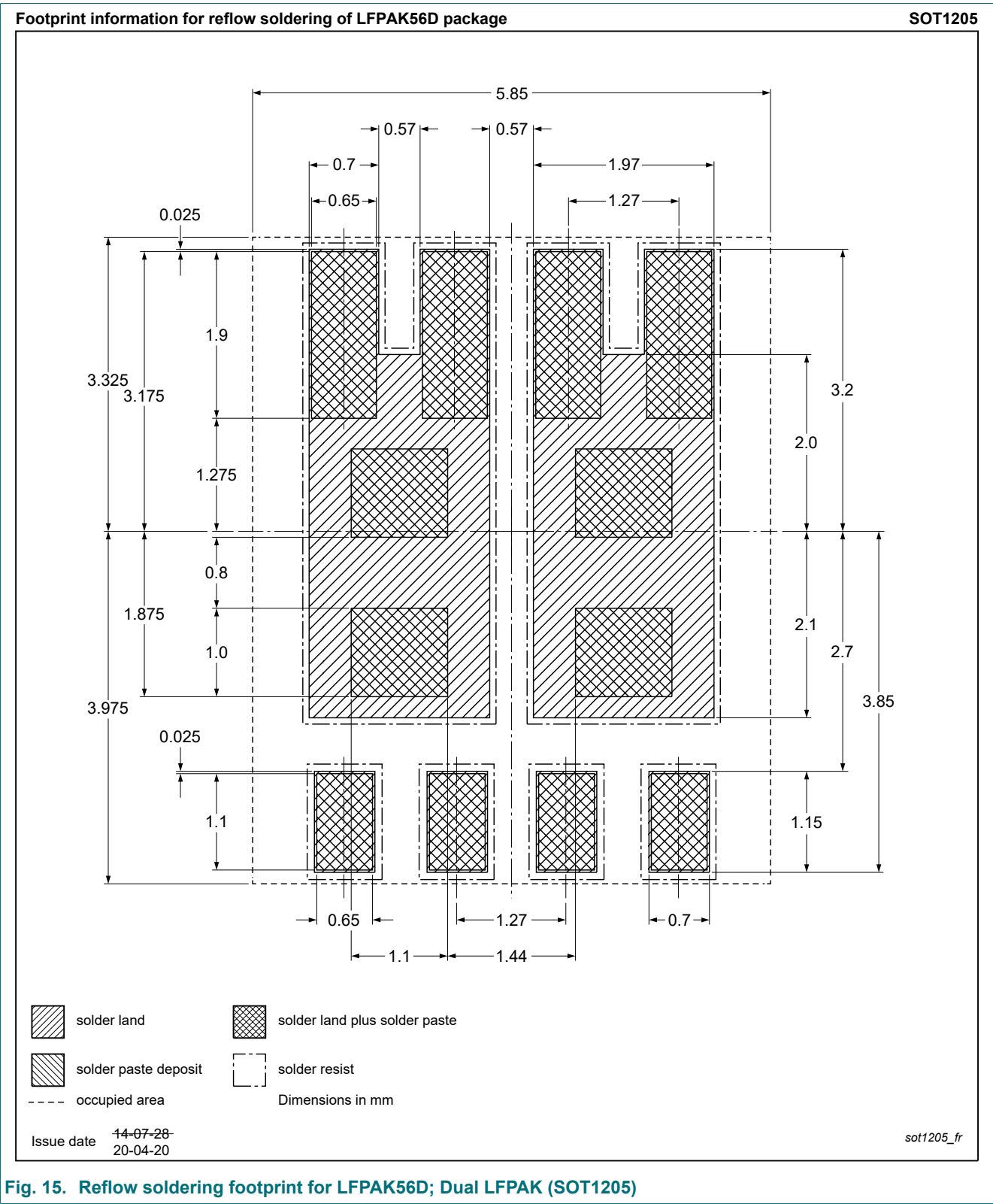


Fig. 14. Package outline LFAK56D; Dual LFAK (SOT1205)
