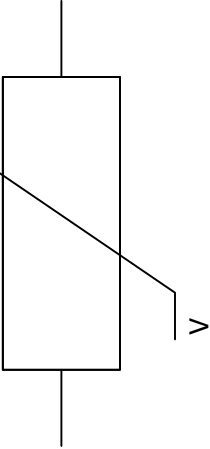

In addition, sufficient reliability evaluator checks for safety must be performed on every electronic component which is used in electrical circuits that require high safety and reliability functions or performance.
