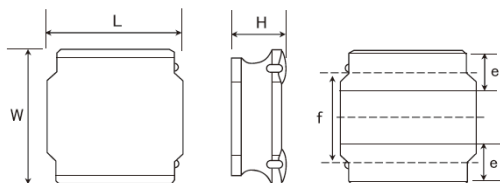

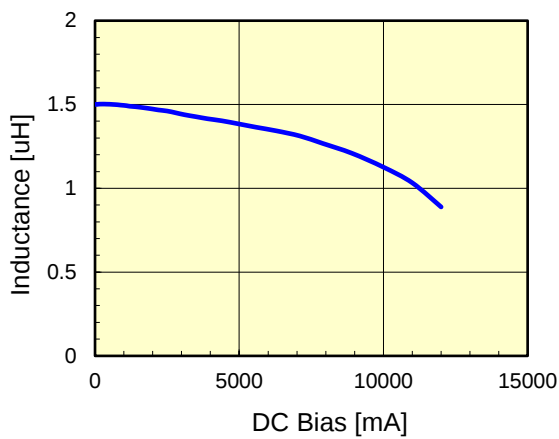

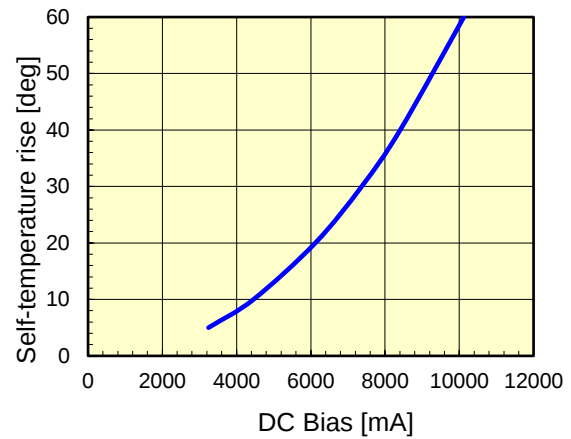

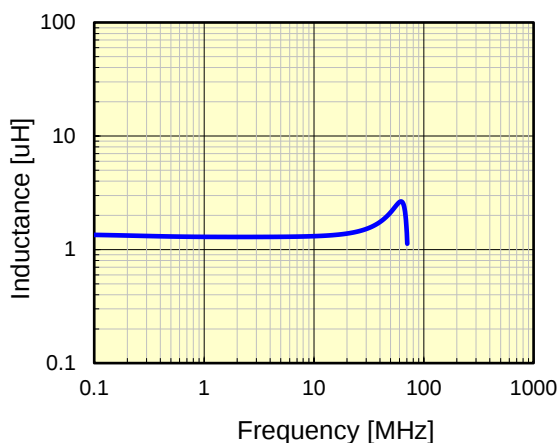
DC Bias vs Inductance
