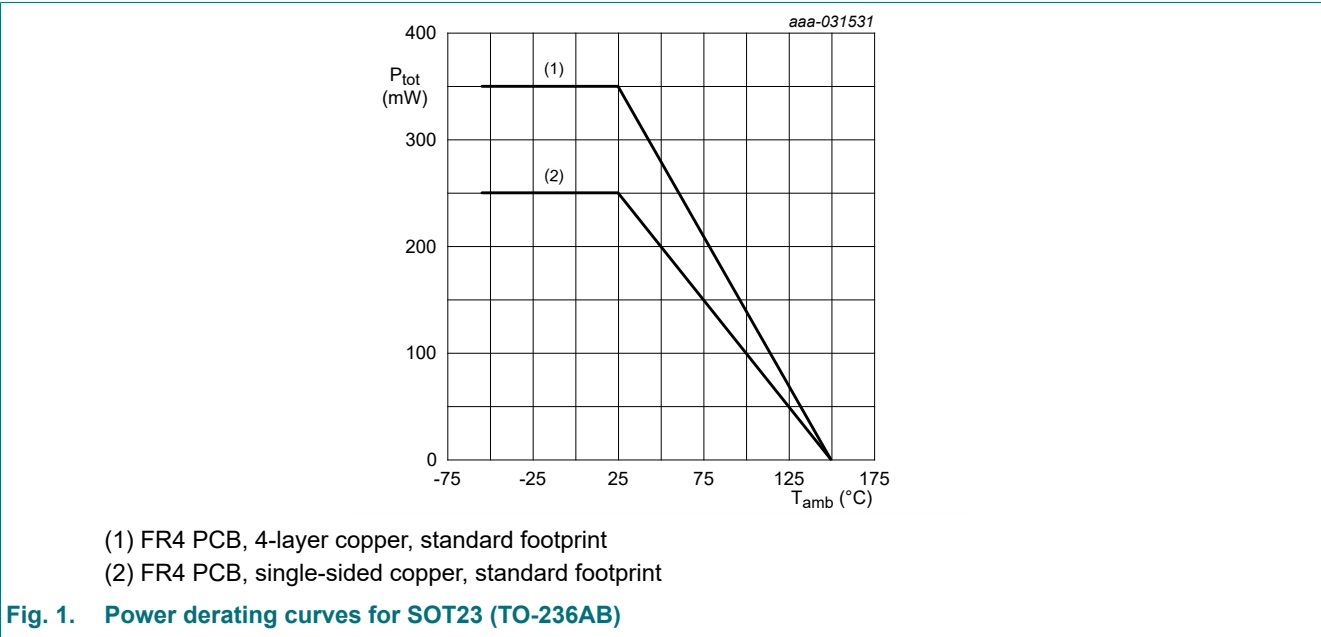

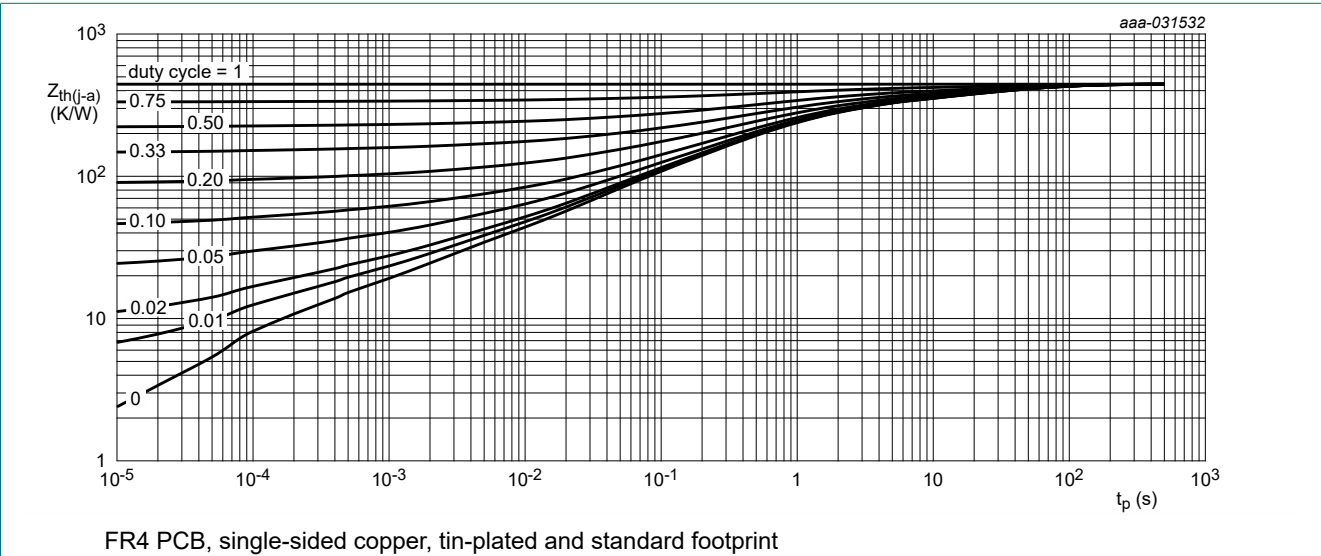


Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

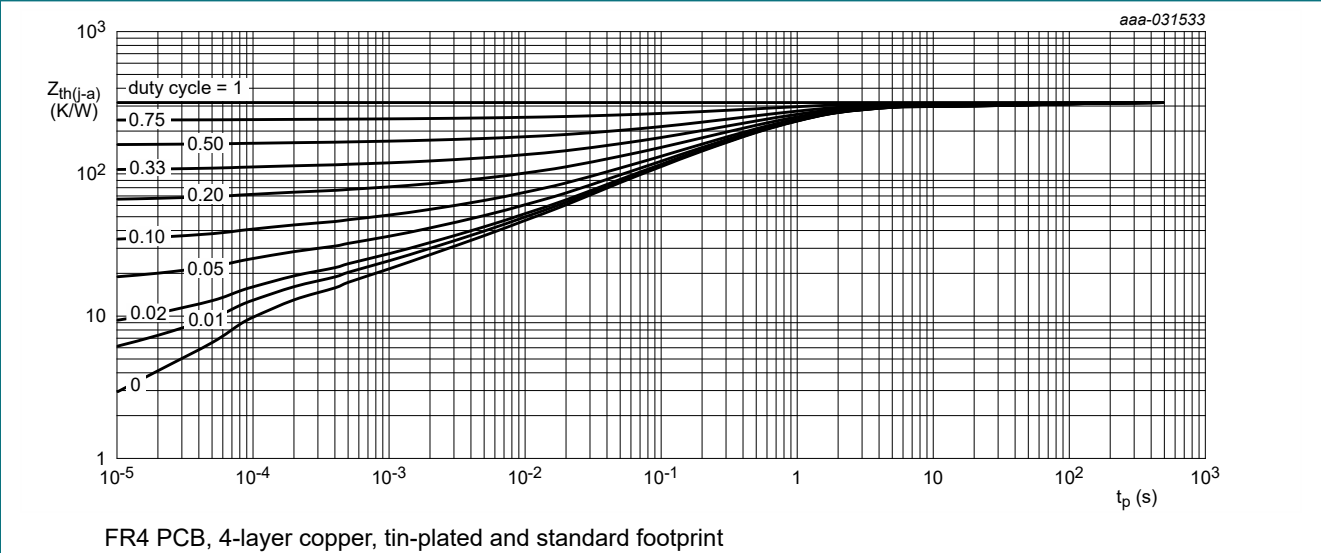


Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

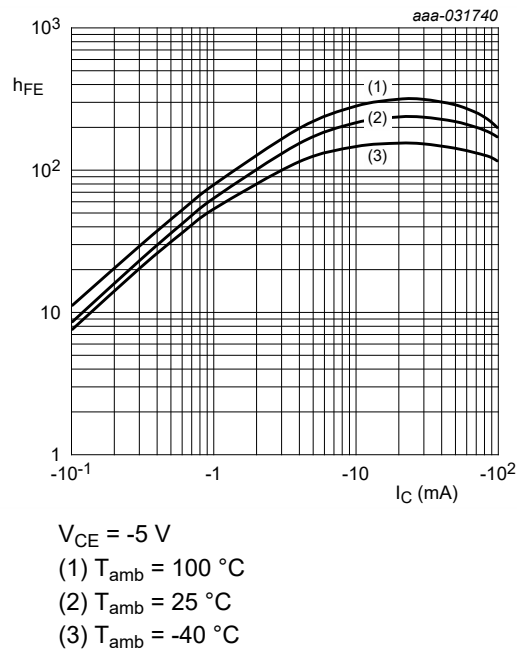


Fig. 4. NHDTA123JT-Q: DC current gain as a function of collector current; typical values

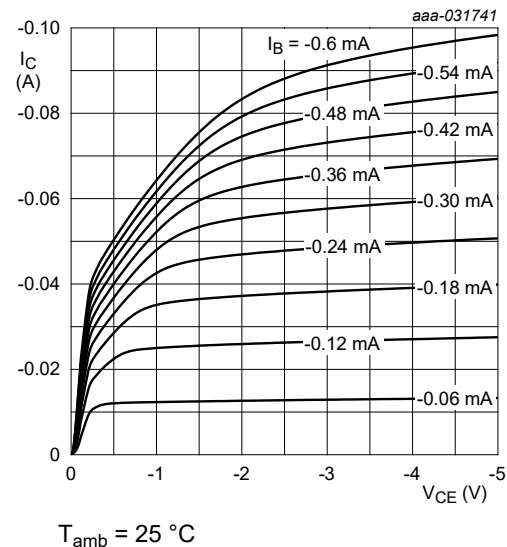


Fig. 5. NHDTA123JT-Q: Collector current as a function of collector-emitter voltage; typical values

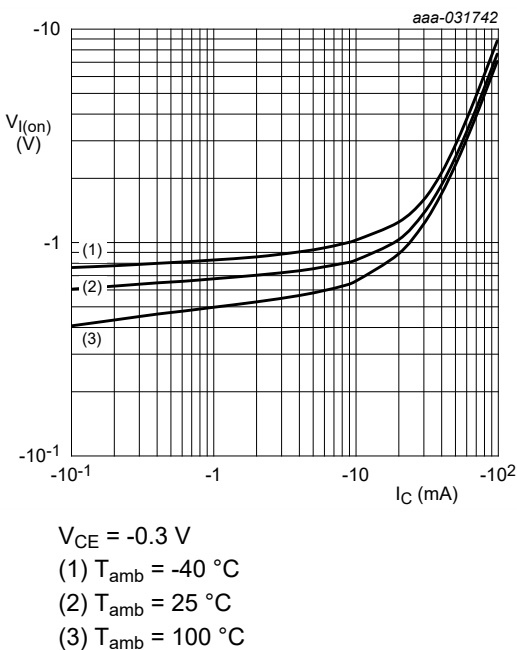


Fig. 6. NHDTA123JT-Q: On-state input voltage as a function of collector current; typical values

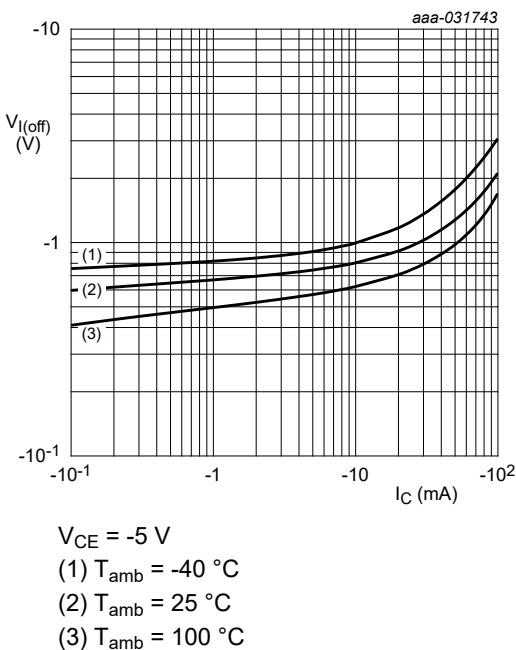


Fig. 7. NHDTA123JT-Q: Off-state input voltage as a function of collector current; typical values

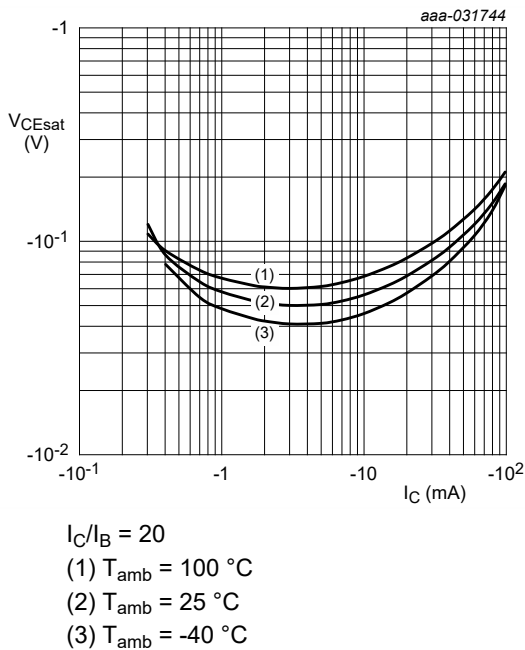


Fig. 8. NHDTA123JT-Q: Collector-emitter saturation voltage as a function of collector current; typical values

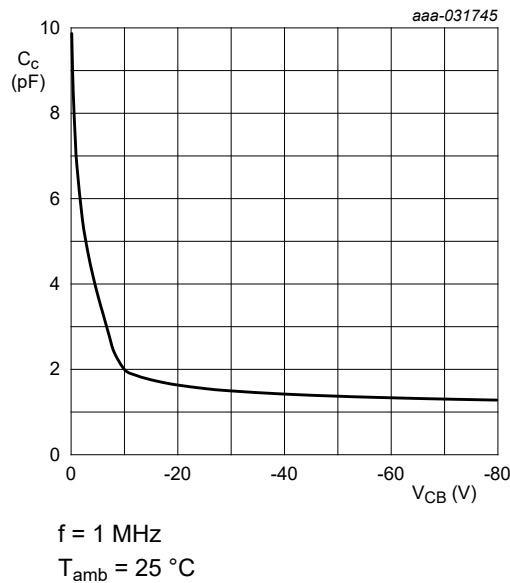


Fig. 9. NHDTA123JT-Q: Collector capacitance as a function of collector-base voltage; typical values

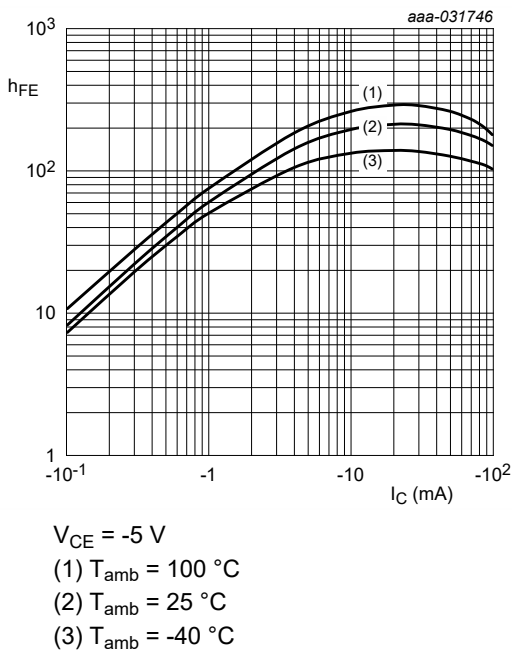


Fig. 10. NHDTA143ZT-Q: DC current gain as a function of collector current; typical values

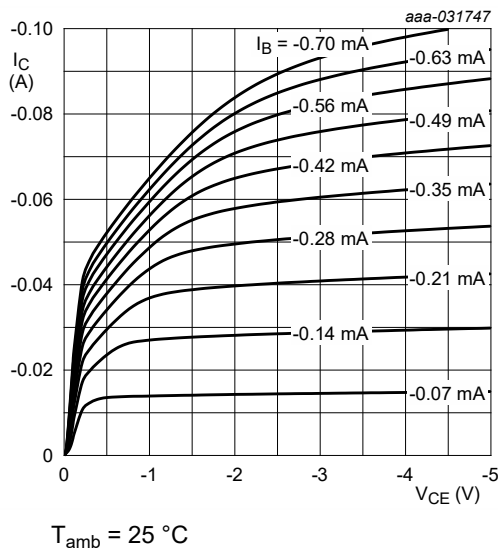


Fig. 11. NHDTA143ZT-Q: Collector current as a function of collector-emitter voltage; typical values

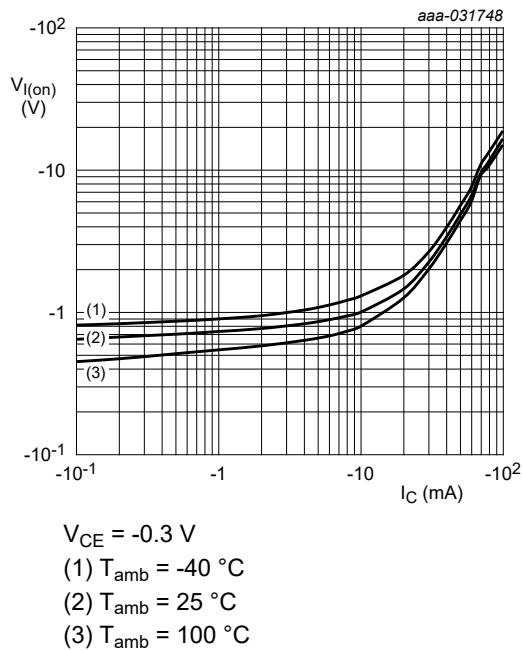


Fig. 12. NHDTA143ZT-Q: On-state input voltage as a function of collector current; typical values

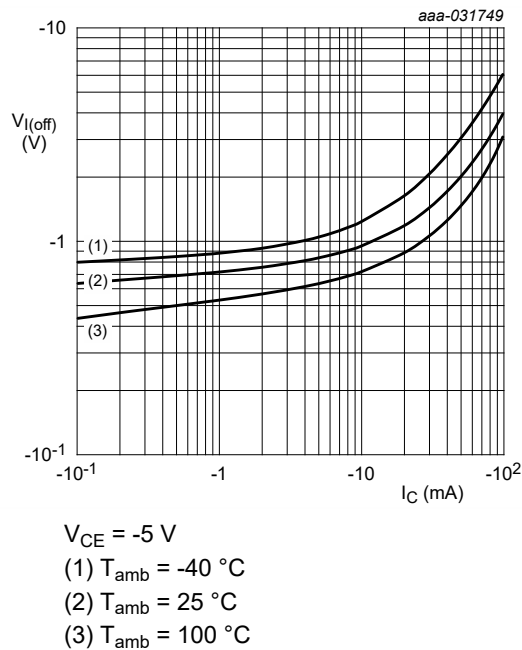


Fig. 13. NHDTA143ZT-Q: Off-state input voltage as a function of collector current; typical values

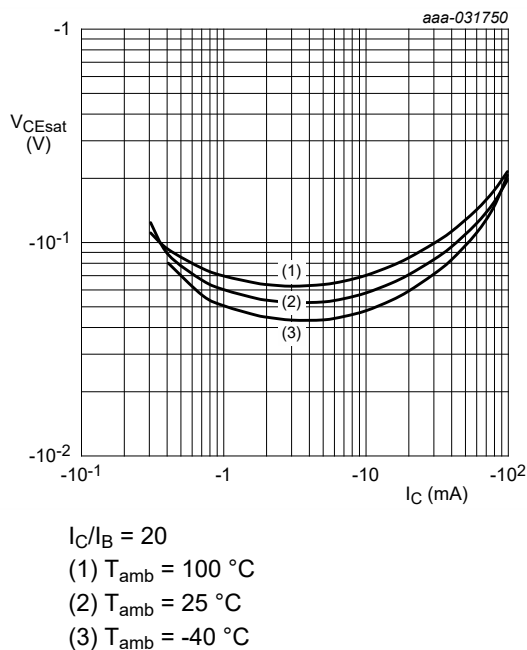


Fig. 14. NHDTA143ZT-Q: Collector-emitter saturation voltage as a function of collector current; typical values

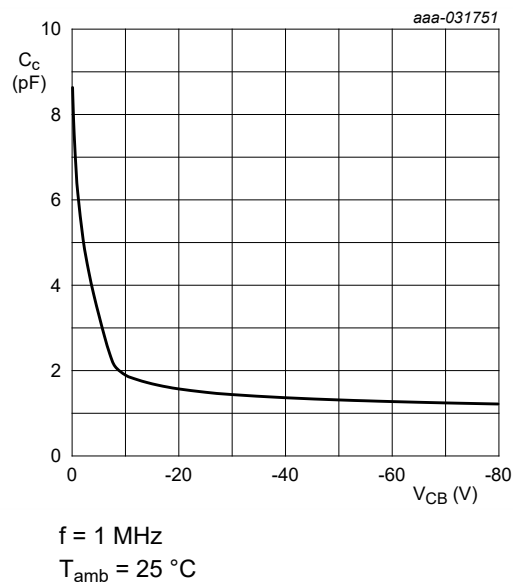


Fig. 15. NHDTA143ZT-Q: Collector capacitance as a function of collector-base voltage; typical values

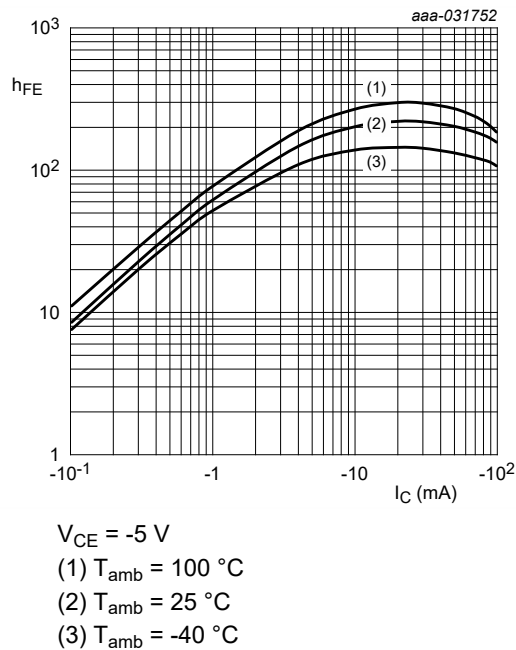


Fig. 16. NHDTA114YT-Q: DC current gain as a function of collector current; typical values

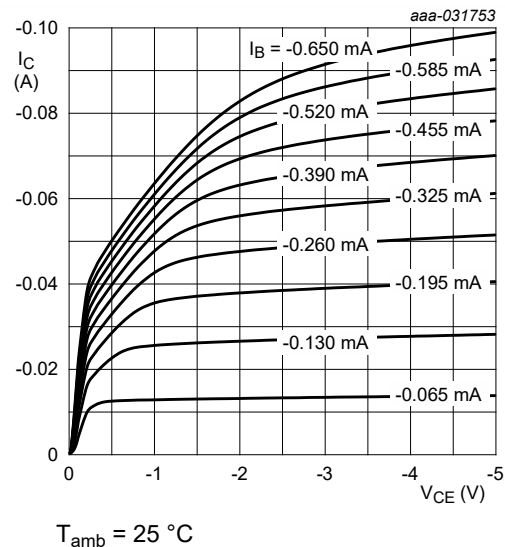


Fig. 17. NHDTA114YT-Q: Collector current as a function of collector-emitter voltage; typical values

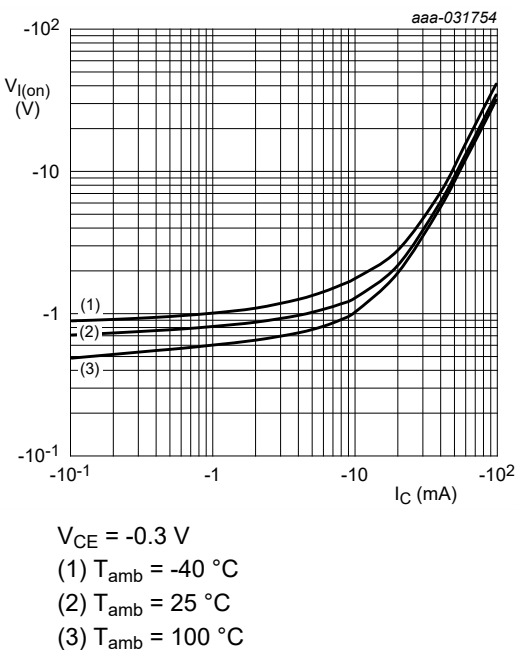


Fig. 18. NHDTA114YT-Q: On-state input voltage as a function of collector current; typical values

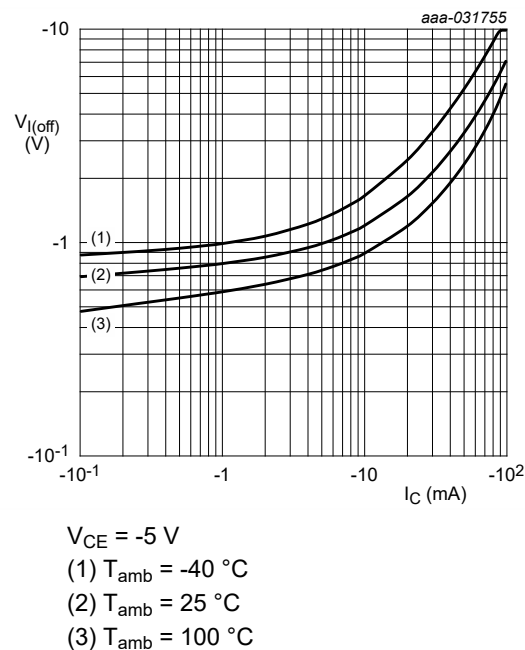
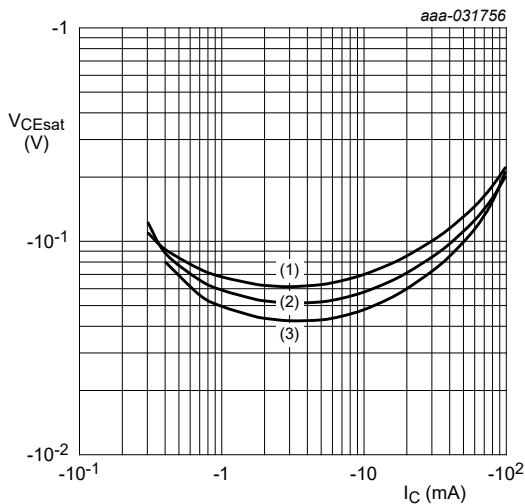
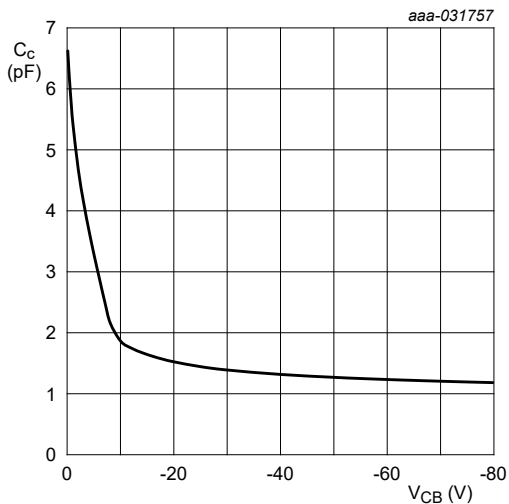


Fig. 19. NHDTA114YT-Q: Off-state input voltage as a function of collector current; typical values



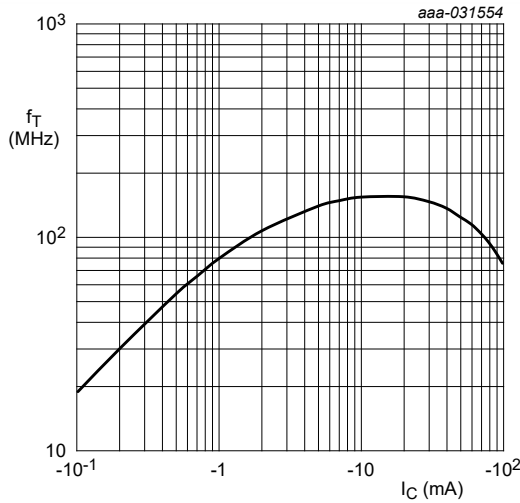

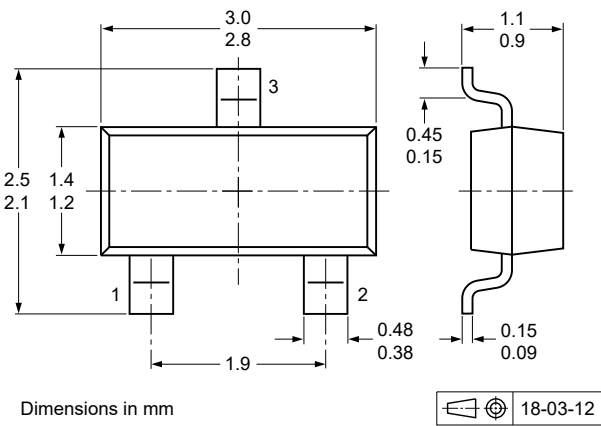


Fig. 24. Package outline SOT23

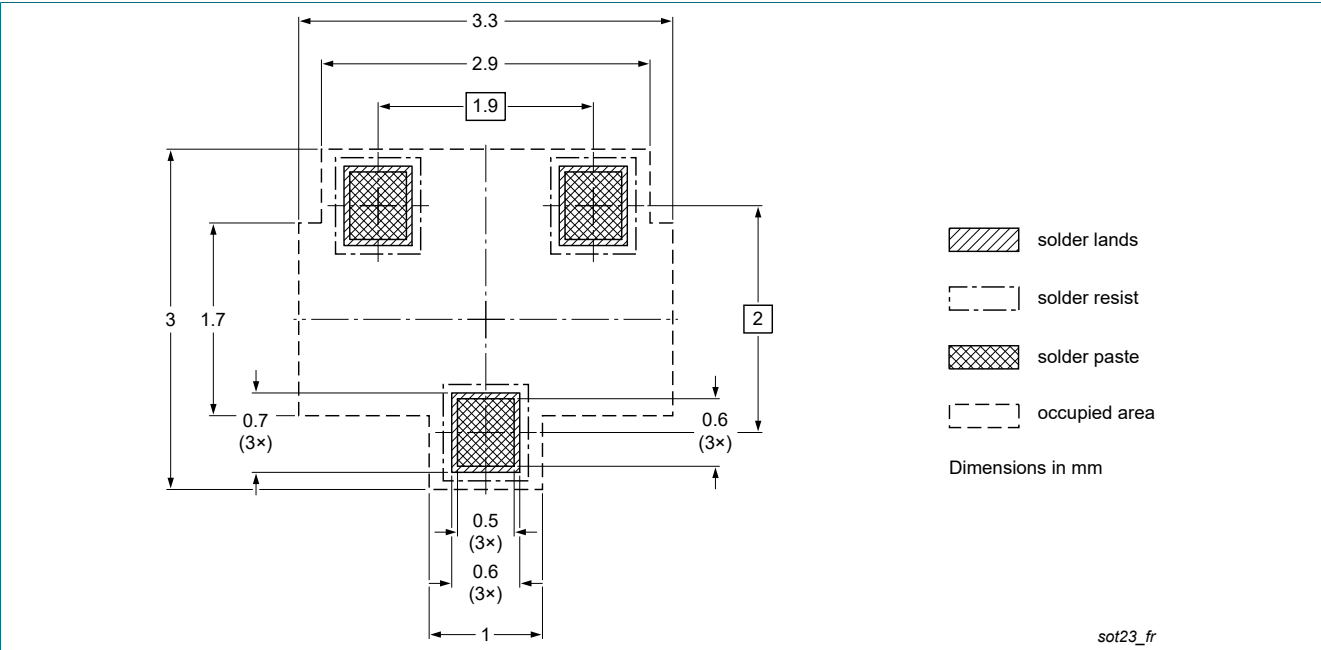


Fig. 25. Reflow soldering footprint for SOT23

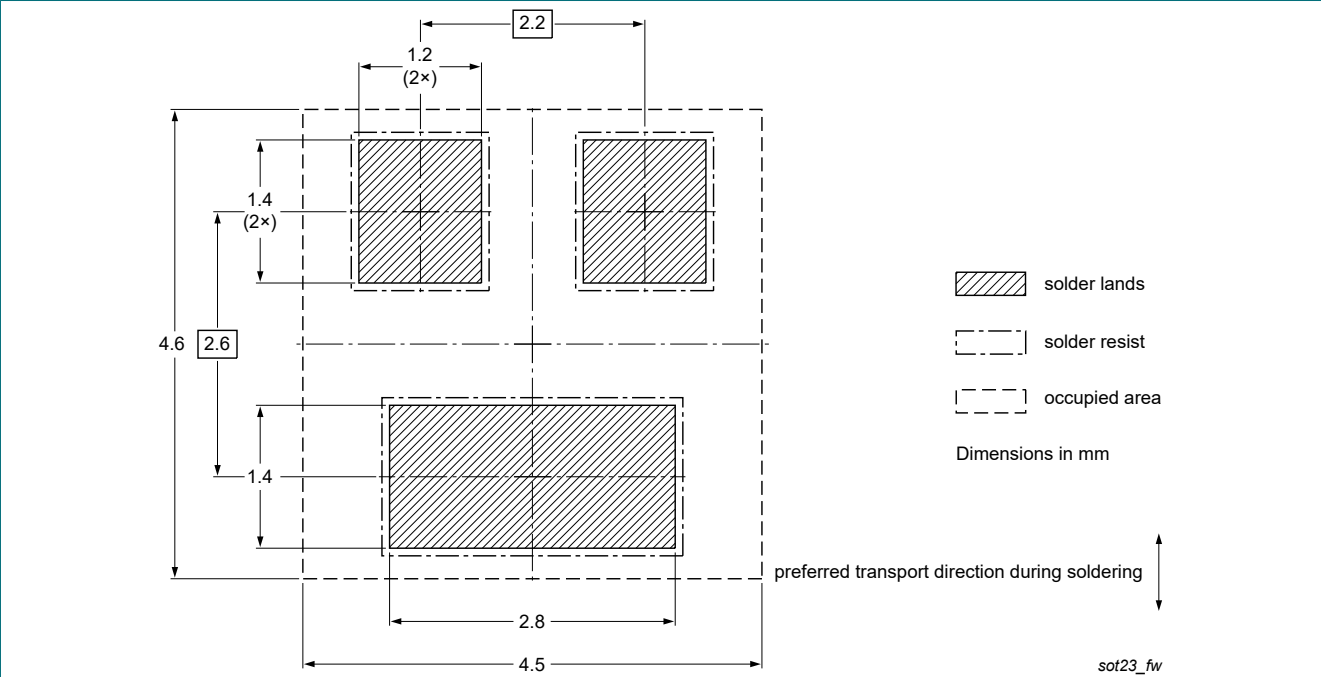


Fig. 26. Wave soldering footprint for SOT23
