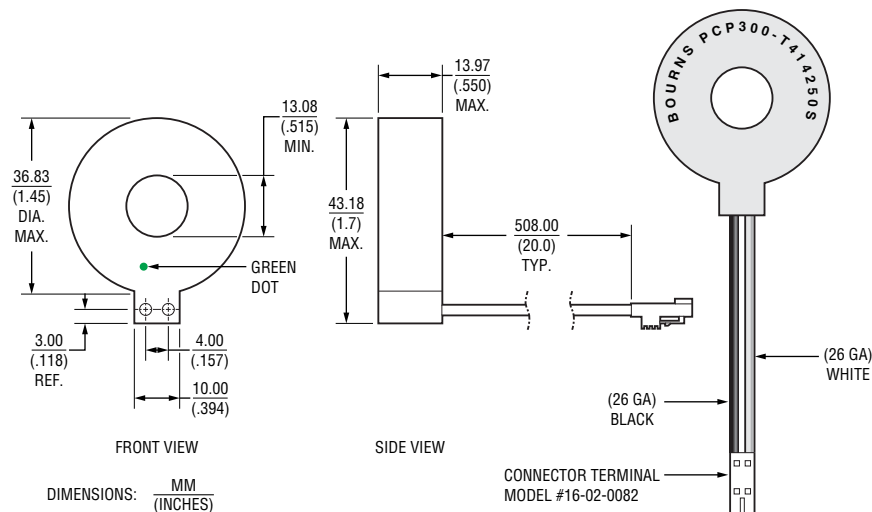

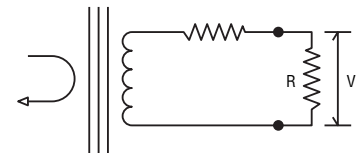

Electrical Schematic

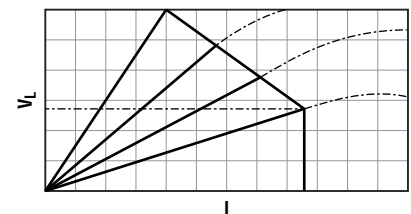
