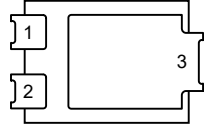
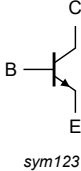

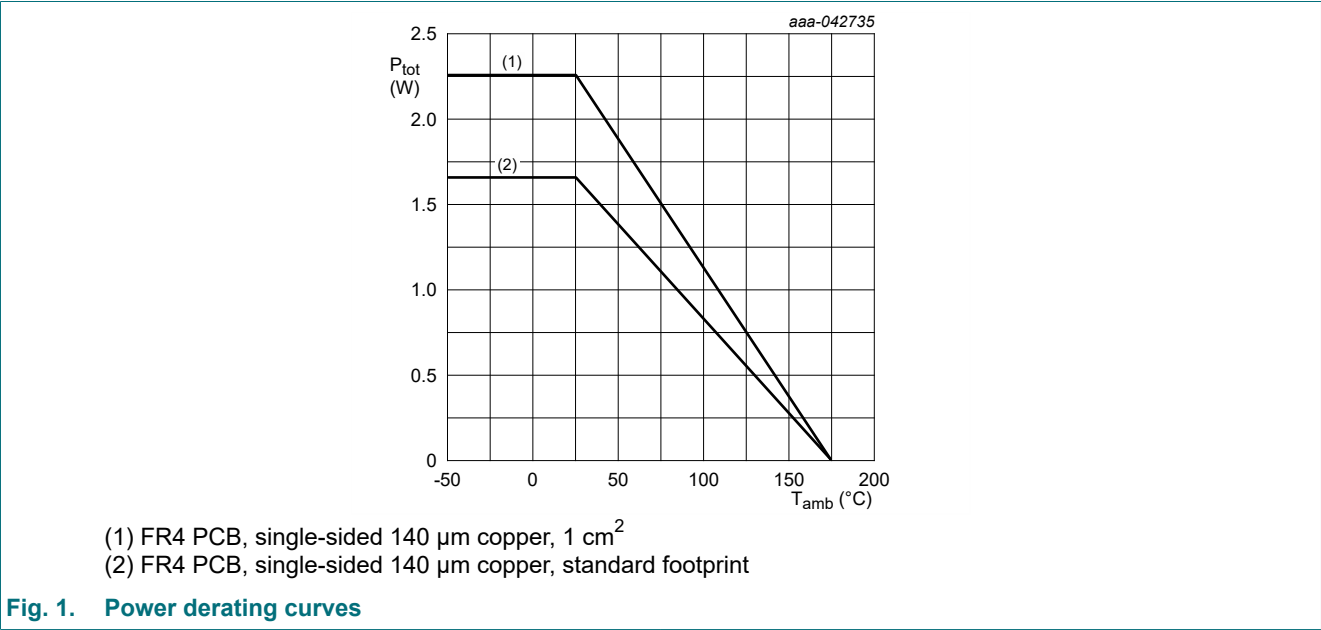


Fig. 1. Power derating curves

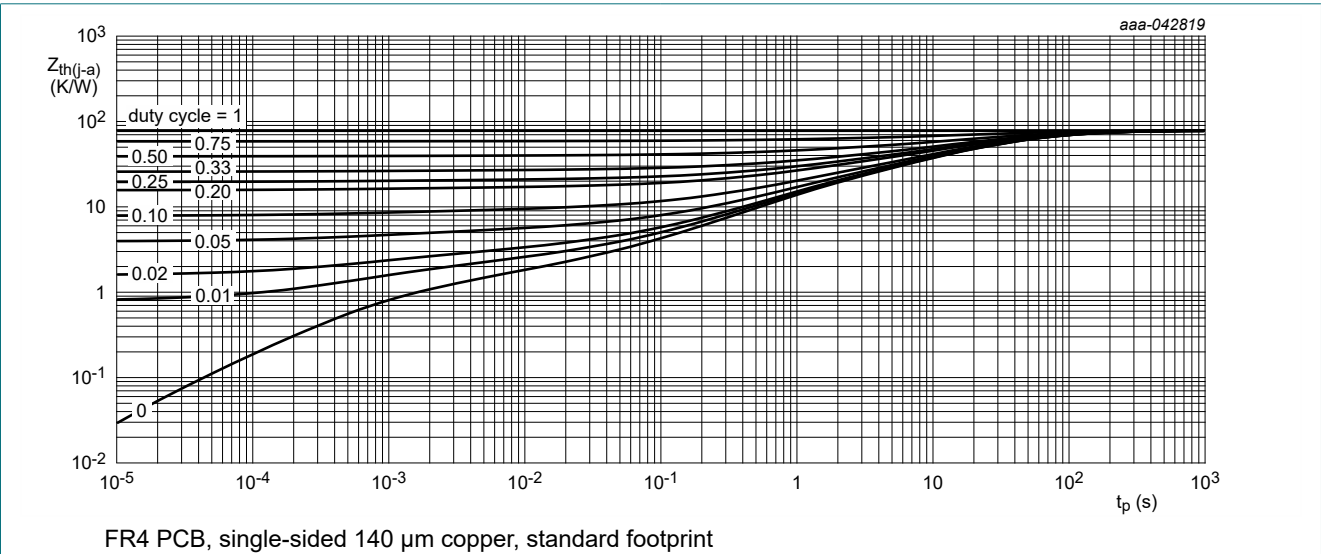


Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

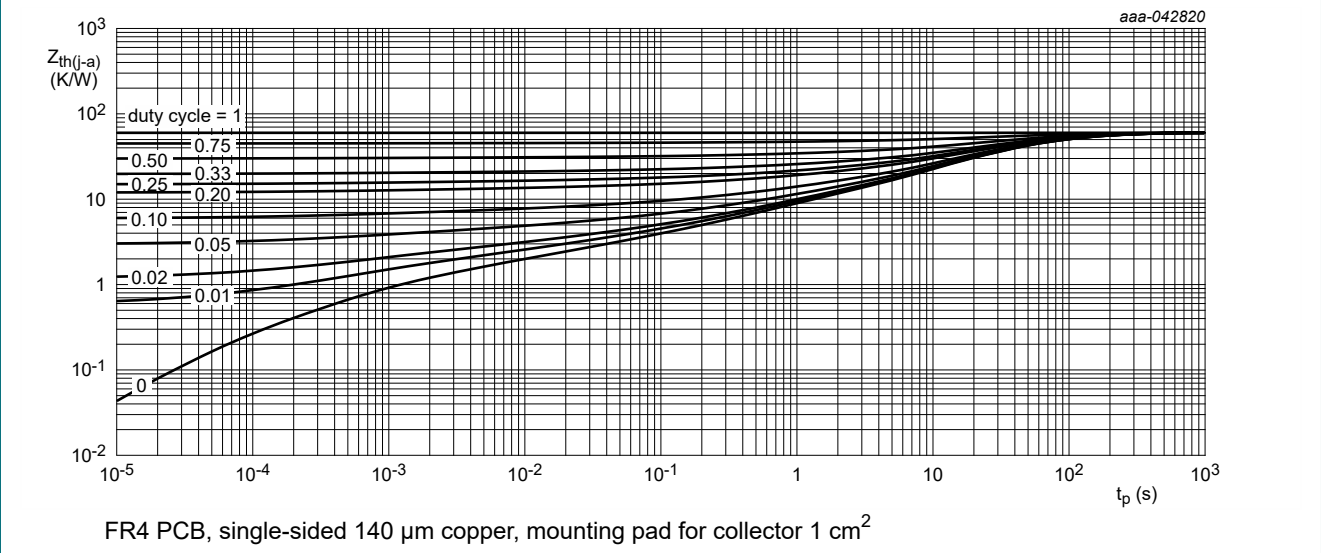


Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

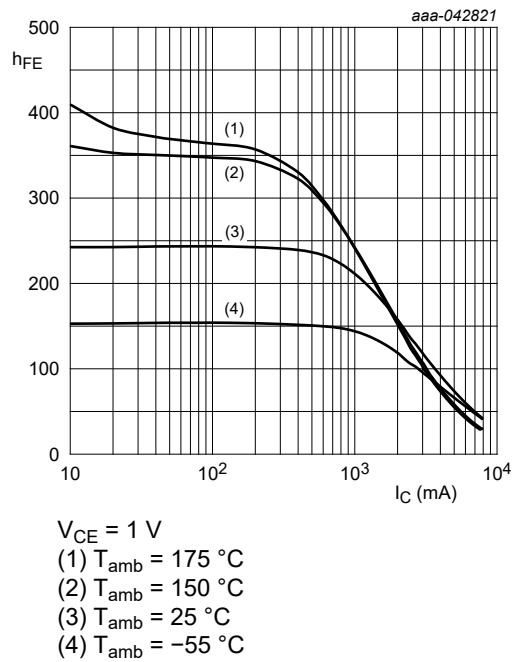


Fig. 4. DC current gain as a function of collector current; typical values

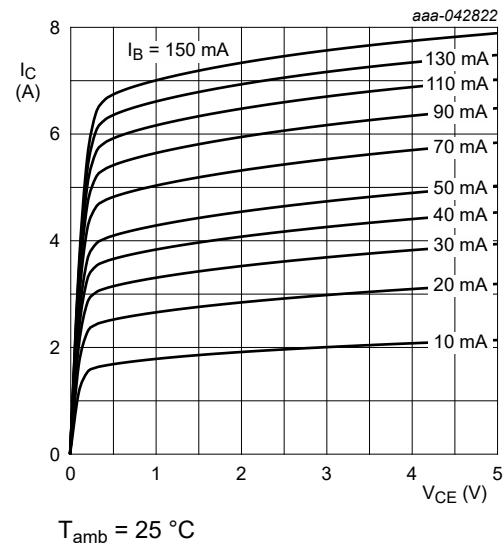


Fig. 5. Collector current as a function of collector-emitter voltage; typical values

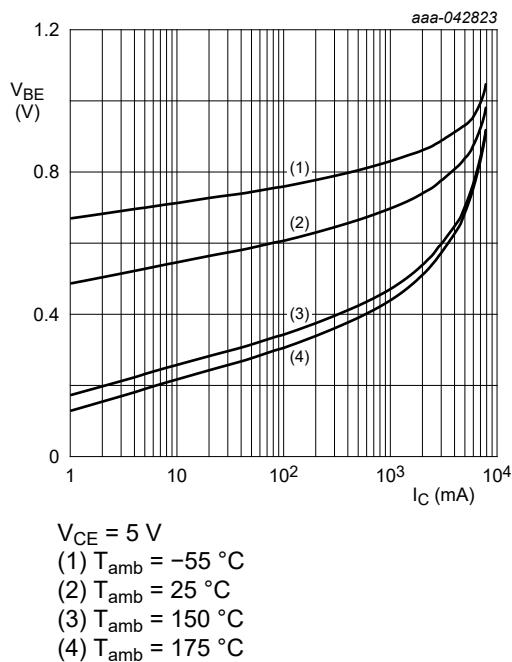


Fig. 6. Base-emitter voltage as a function of collector current; typical values

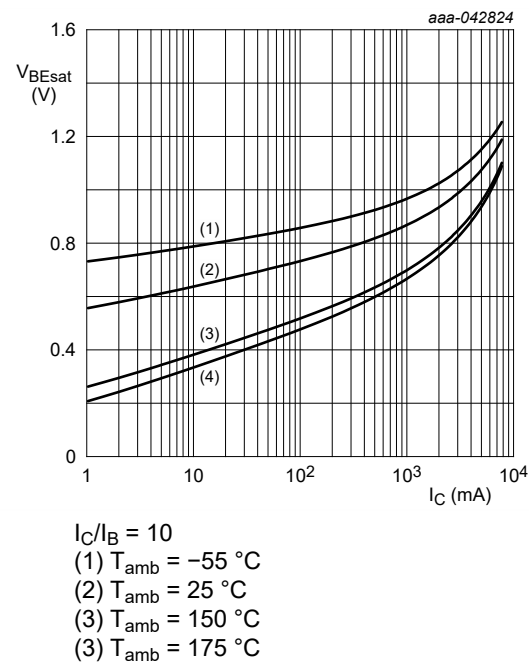


Fig. 7. Base-emitter saturation voltage as a function of collector current; typical values

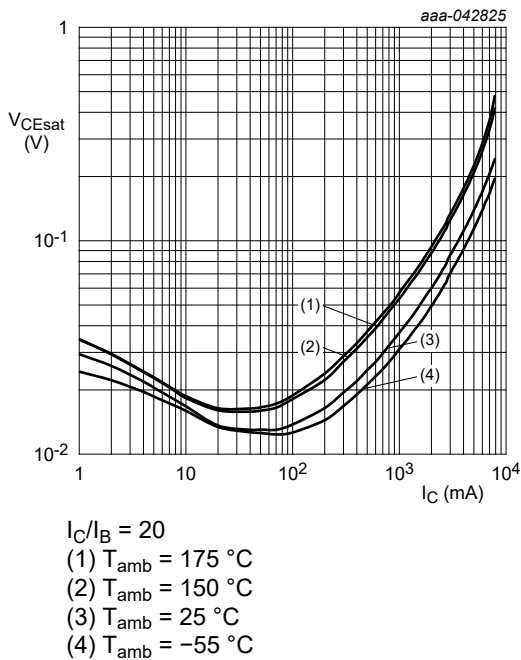


Fig. 8. Collector-emitter saturation voltage as a function of collector current; typical values

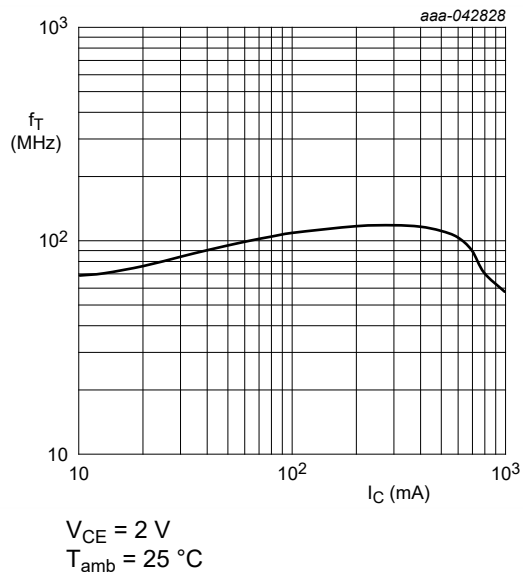


Fig. 9. Transition frequency as a function of collector current; typical values

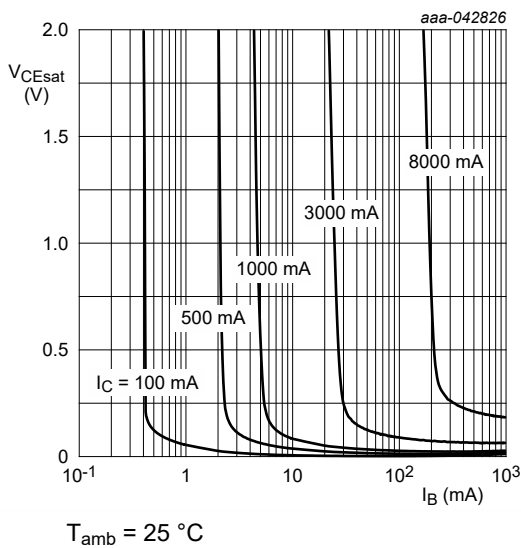


Fig. 10. Collector-emitter saturation region as a function of base current; typical values

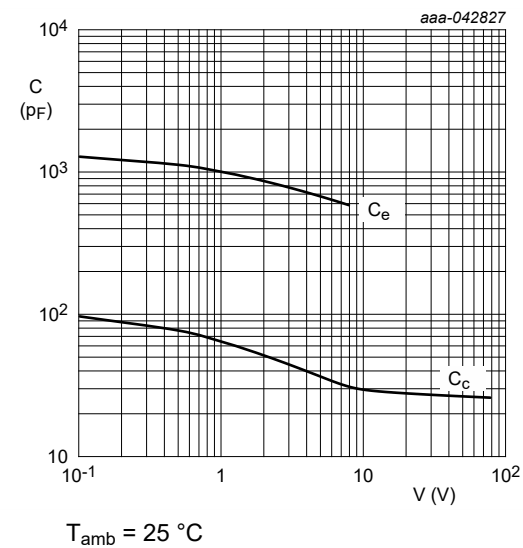


Fig. 11. Input/output capacitance as a function of input/output voltage

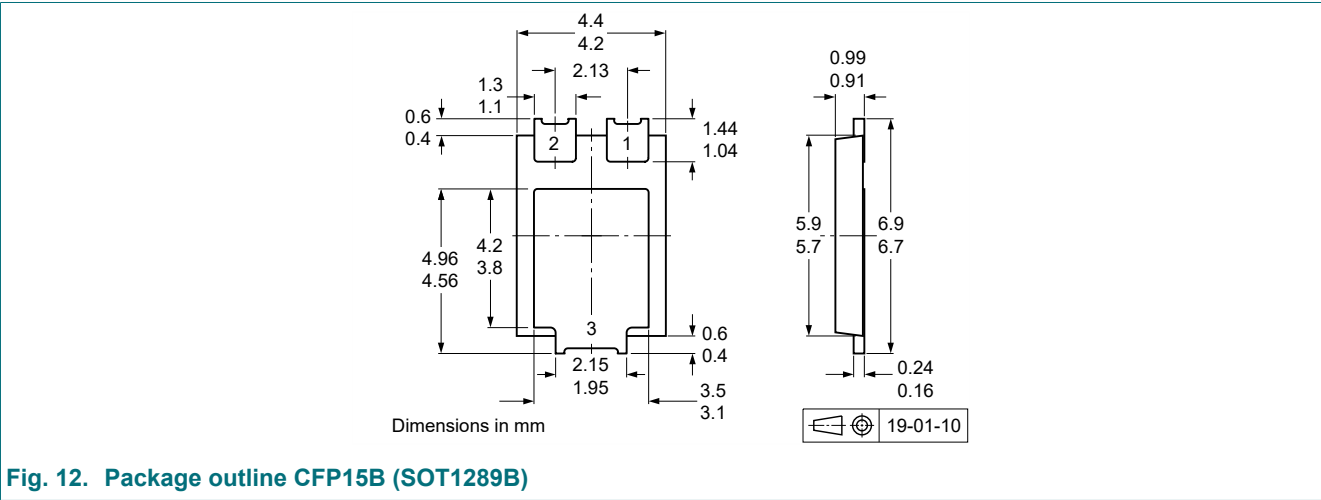


Fig. 12. Package outline CFP15B (SOT1289B)

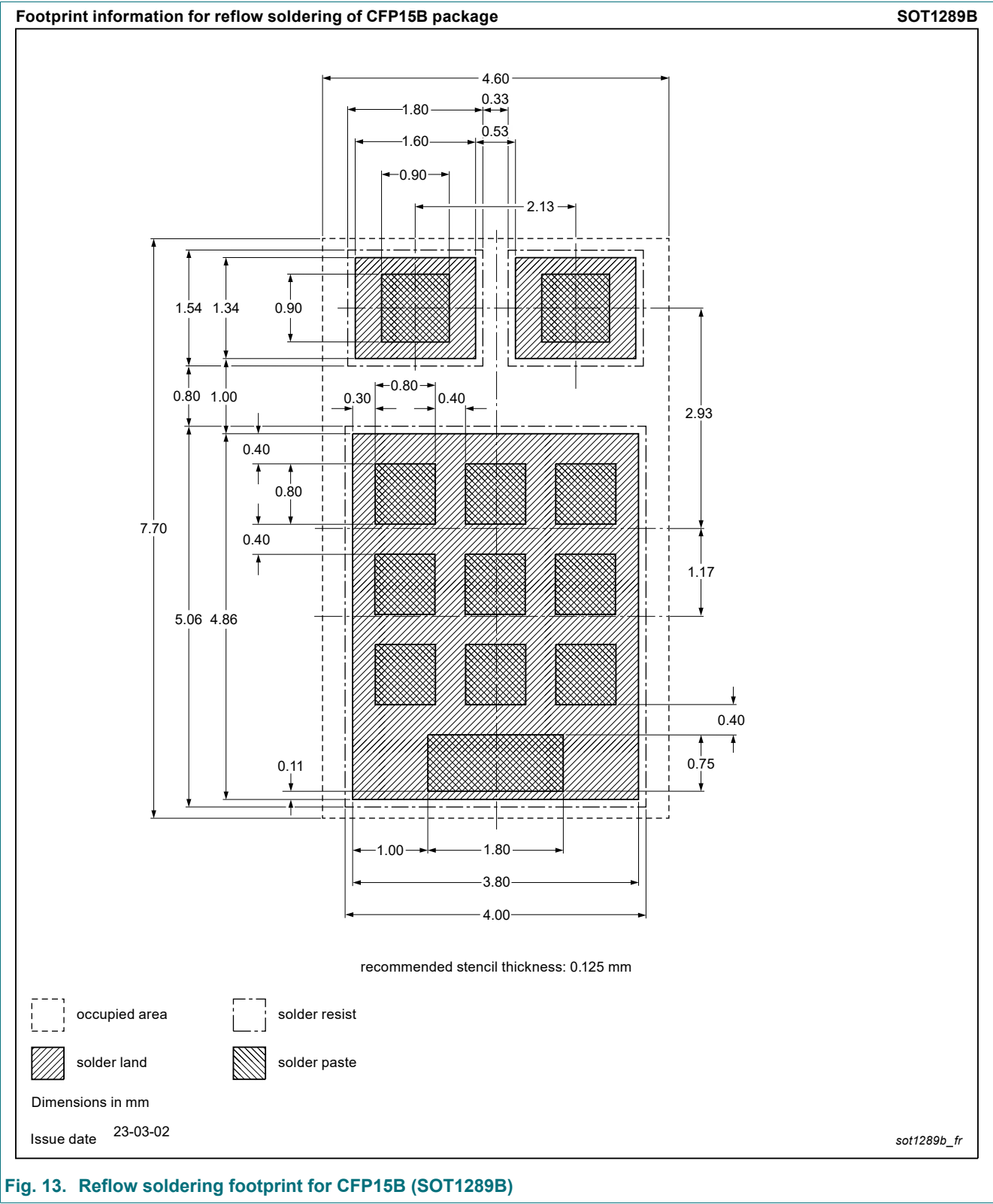


Fig. 13. Reflow soldering footprint for CFP15B (SOT1289B)
