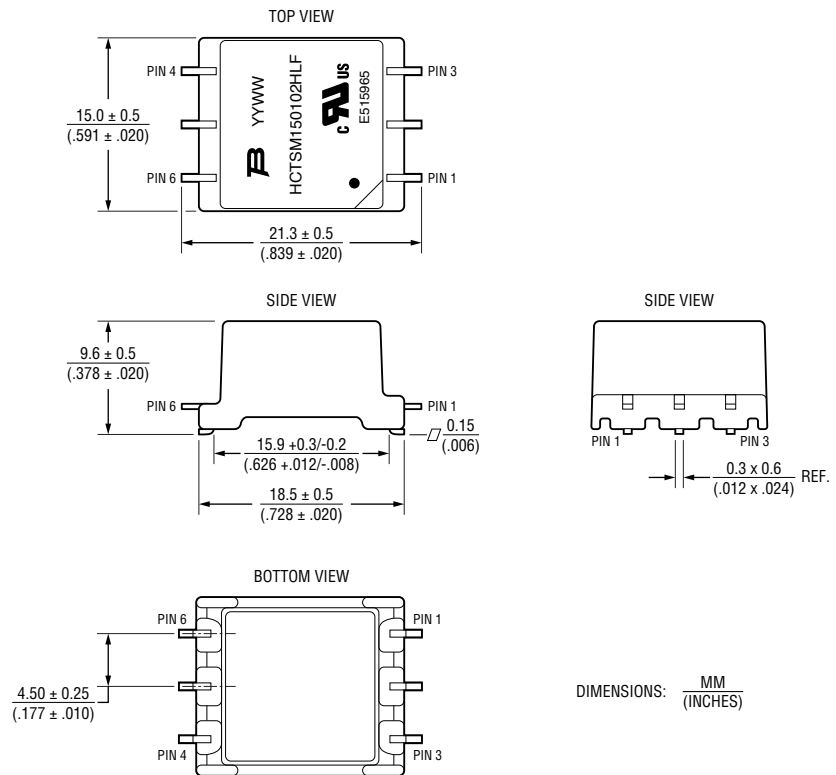

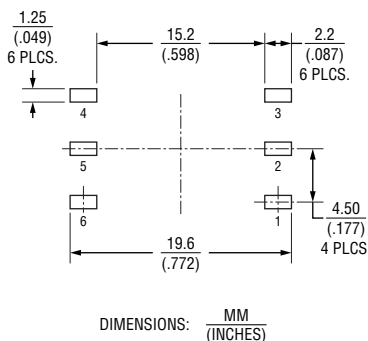

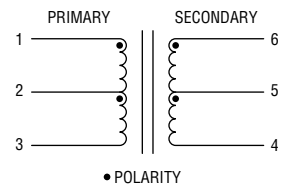
Product Dimensions

Electrical Schematic



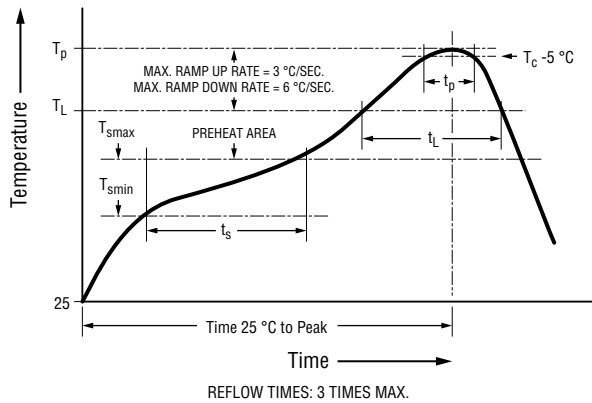

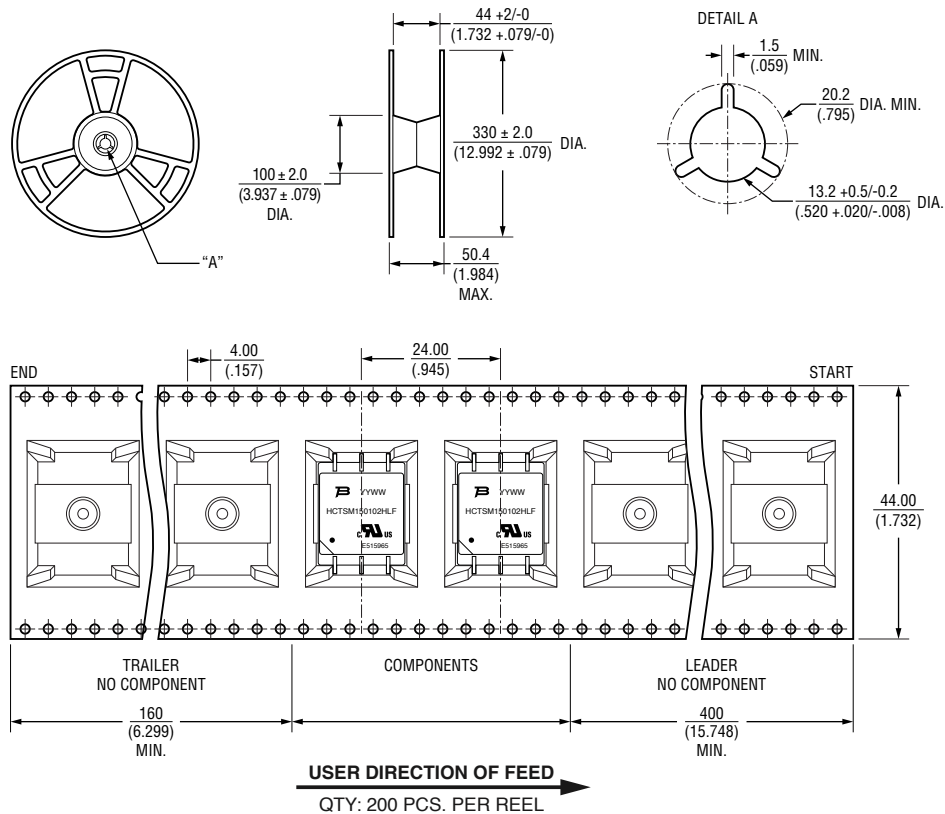
