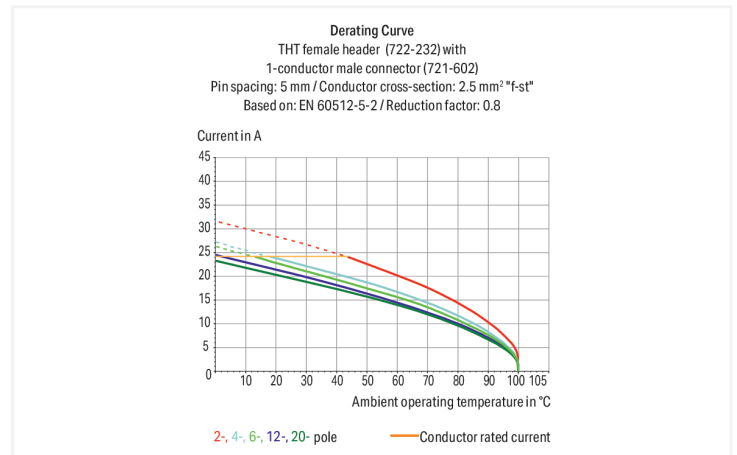

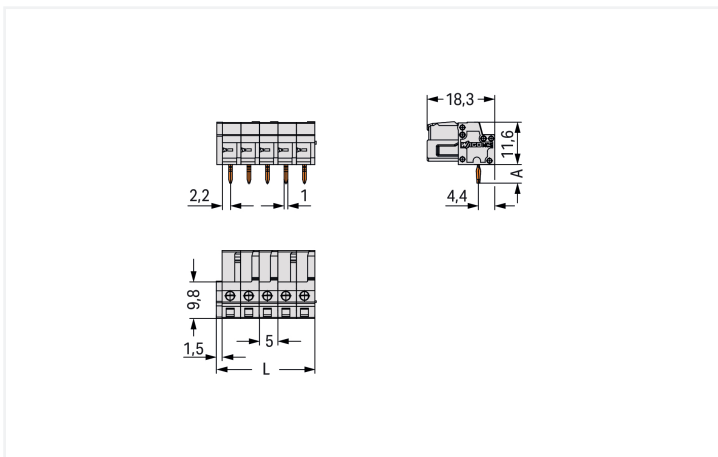

The contact surface is coated with tin. The pcb connector is designed for THT soldering.
